

It is a class A misdemeanor punishable, notwithstanding the provisions of section 560.021, RSMo, to the contrary, for a term of imprisonment not to exceed one year in the county jail or a fine not to exceed ten thousand dollars or both, for anyone to sign any initiative petition with any name other than his or her own, or knowingly to sign his or her name more than once for the same measure for the same election, or to sign a petition when such person knows he or she is not a registered voter.

Be it resolved by the people of the state of Missouri that the Constitution be amended:

Article I of the Constitution is revised by amending Section 29 to read as follows:

Section 29. That employees and employers shall have the right to organize and to bargain collectively through representatives of their own choosing. That an employee accepting employment with an employer in a position represented by a representative of employees' choosing may be required to contribute that employee's pro-rata share of representational costs if the employer and employees' chosen representative have so agreed.
