
Missouri Courts

Missouri has a three-tier court system. Article V of the Constitution, as amended by Missouri voters in 1976, vests the judicial power in a Supreme Court, the state's highest court with statewide jurisdiction; in a Court of Appeals consisting of districts established by the General Assembly; and in a system of circuit courts which have original jurisdiction over all cases and matters, civil and criminal, within the circuit.

The Supreme Court and Court of Appeals have general superintending control over all courts and tribunals within their jurisdictions. Original remedial writs may be issued and determined by the Supreme Court and Court of Appeals. Decisions of the Supreme Court are controlling in all other courts.

The Circuit Court may be organized into divisions: circuit, associate, juvenile, family and probate. Circuit judges may hear and determine all cases and matters within the jurisdiction of the Circuit Court.

The number of circuit judges is determined by the General Assembly. The Constitution requires at least one circuit judge in each of Missouri's 45 judicial circuits.

Associate circuit judges may hear those types of civil and criminal matters specified in Chapters 472, 476, 478 and 482 of the Revised Statutes. By agreement of the parties, by assignment of the circuit's presiding judge or by local court rule, associate circuit judges may hear any matter pending in the Circuit Court. Associate circuit judges may hear any case upon assignment by the Supreme Court.
