We command you to take Coleman Reid

if he be found in your county and to safely keep
so that you have his body before the Judge of our Boone
Circuit Court on the first day of the next Term thereof to
be held at the Court House in the Town of Columbia within
and for Boone County on the third Monday in
August next 1848, to answer an Indictment found
against him by the Grand Jury for Boone County
for a felonious assault and Battery
and have you then and there this writ.

The Grand Jurors for the State of Missouri for the body of the County of Boone appeared upon their oath present that Coleman Reed late of said County of Boone on the nineteenth day of December in the year of our Lord one thousand eight hundred and forty seven with force and arms at the County of Boone appeared in and upon one Thomas J. Arnold on purpose and of his malice aforethought unlawfully and feloniously on a point did make and that the said Coleman Reed then & there on purpose and of his malice aforethought unlawfully and feloniously with a certain deadly weapon called a knife of the length of six inches and the width of half an inch the said Thomas J. Arnold did strike cut and ^{stab} and upon the left eye and left side of the face of him the said Thomas J. Arnold with intent by such striking cutting and stabbing on purpose and of his malice aforethought unlawfully and feloniously the said Thomas J. Arnold to kill to the great damage of the said Thomas J. Arnold Contrary to the form of the Statute in such Case made and provided and against the peace and dignity of the State

and arms at the County of Boone aforesaid
in and upon one Thomas J Arnold in the
peace of the State then & there being there
& there unlawfully and feloniously did
make an assault and that the said Coleman
Reed with a certain dangerous weapon
called a knife which he the said Coleman

Reed in his right hand then & there had and held the said Thomas T. Arnold in and upon the left side of the face and neck of him the said Thomas T. Arnold then & there unlawfully and feloniously did strike cut and stab giving to the said Thomas T. Arnold then & there with the knife aforesaid in and upon the left side of the face & neck of him the said Thomas T. Arnold three dangerous wounds each of the length of three inches and of the depth of half an inch by means of which striking cutting and staking as aforesaid he the said Thomas T. Arnold did thereby then & there receive great bodily harm and other wrongs to the said Thomas T. Arnold then & there and contrary to the forms of the Statute in such Case made and provided and against the peace and dignity of the State.
