Said affiant, Daisy Cotterman, further states that she is the sister of Harley Clayton Tutt and that said Harley Clayton Tutt was born on the tenth day of October, 1878 in the City of Crawfordsville in the County of Montgomery in the State of Indiana; furthermore, that said Harley Clayton Tutt, died on the 27th day of March in the year 1928 in the City of Kansas City in the State of Missouri at the age of forty nine years, five months and seventeen days.

Said affiant, Daisy Cotterman, further states that Harley Clayton Tutt spent the early part of his life in Crawfordsville, Indiana, where he was employed by the Pennsylvania Railroad Company; that he came to Indianapolis, Indiana in 1908 and was employed by the Cincinnati, Hamilton and Dayton Railroad Company; that later he was employed on various other railroads; that returning to Indianapolis he was employed as a switchman for the Big Four Railroad Company, where he accidentally lost his left limb after which he retired from active railroad service; that he had lodge affiliations with both Railroad Trainmen and order of Railway Conductors.
