Gentlemen:

We thank you very kindly for copy of report as to the death of Joseph Henry Hutsell, 3218 Gillham Road, Kansas City, Missouri, June 15, 1931, Registration District 393, Primary Registration District No. 1002, file No. 21502, registered No. 2637, number of copy of this report 5047. We note in answer to question No. 17, that the informant, Celia Rayborn, who is reported as the daughter of Joseph Henry Hutsell, gives the age of the deceased as 53 years, 8 months and 13 days, and we have evidence in our files that this is not correct. In answer to question No. 6, the date of birth is given as October 2, 1877, and this date of birth was given as a reason that it compares with the date of birth on the application for an insurance policy with this company dated March 6, 1931.


We have evidence in our file in inspection reports of this case that this man was at least 70 years of age, and there is also evidence of the death of his first wife when he was 50 years old, and he did not marry again until ten years later. The sheriff at Hartville, Missouri, who knew this man, Hutsell, for a great many years, states that he was at least 70 years of age at his death. We note on the election commissioner's report that Joseph H. Hutsell registered in his precinct in Kansas City, Missouri, September 25, 1928, and he gave his age to the election commissioner as 67. Therefore, he must have been over 70 years of age at his death. We do not know whether this information is of any value to you or not, but it is very evident that the informant, in making out this death report, knew that his date of birth and age at death was incorrect, and that she had a purpose for doing so.

Therefore, we pass this information on to you for such purpose as you may wish to use it for.



While, of course, I do not know what your State Law is in regard to misrepresentation to your Department, if you wish further evidence as regards this man's age, we will be glad to give it to you.


