FOR INFORMATION OF THE MEMPHIS OFFICE, THE FOLLOWING IS A SUMMARY OF THE INFORMATION RECEIVED FROM THE CLEVELAND OFFICE ON APRIL 4, 1968:

ON APRIL 4, 1968, THE CLEVELAND OFFICE RECEIVED A TELEPHONE CALL FROM AN INDIVIDUAL WHO IDENTIFIED HIMSELF AS RICHARD J. RAY. HE STATED THAT HE WAS CURRENTLY IN THE CLEVELAND AREA AND WANTED TO SPEAK TO AN INDIVIDUAL WHO IDENTIFIED HIMSELF AS AN FBI AGENT. THE CLEVELAND OFFICE ATTEMPTED TO LOCATE THE INDIVIDUAL BUT WAS UNABLE TO DO SO.

THE CLEVELAND OFFICE IS CURRENTLY ATTEMPTING TO LOCATE THE INDIVIDUAL AND WILL REPORT THE RESULTS OF ITS SEARCH TO THE MEMPHIS OFFICE AS SOON AS POSSIBLE.
