- (6) Payment of any copy/printout fees and search fees may be required before any information will be provided, pursuant to section 610.026, RSMo.
- (7) The provisions of this rule are declared severable. If any fee fixed by this rule is held invalid by a court of competent jurisdiction or

by the Administrative Hearing Commission, the remaining provisions of this rule shall remain in full force and effect, unless otherwise determined by a court of competent jurisdiction or by the Administrative Hearing Commission.
