STATEMENT OF ACTUAL COST

3 CSR 10-5.205 Permits Required; Exceptions

The original estimated public cost for this rulemaking was published in the *Missouri Register* October 1, 2018, (43 MoReg 2816-2821). Even though the actual cost to state agencies and political subdivisions did not exceed the cost estimate by more than ten percent (10%), the estimated costs deviated from the actual costs sufficiently to warrant explanation for purposes of section 536.200.3, RSMo 2020. The actual annual cost to the Department of Conservation in 2019 was approximately two hundred fifty thousand five hundred sixty-six dollars (\$250,566) in lost revenue from permit sales, which is thirteen percent (13%) less than the originally estimated cost of two hundred eighty-eight thousand sixty-six dollars (\$288,066).

The annual cost to the department resulting from this regulation will vary annually based on the number of youth deer and turkey hunters participating in the youth deer and turkey hunting seasons that do not possess a valid hunter education certificate card. The actual annual cost stated above was calculated using the 2019 permit sales information for youth deer and turkey hunters without hunter education certification that obtained a firearms deer or turkey hunting permit to hunt during the youth turkey hunting season or the first portion of the youth deer hunting season. The same assumptions made to determine the original estimated public cost were used to gauge the actual annual cost to the Department of Conservation.
