Historical and Biographical Notes

Jeremiah Wilson "Jay" Nixon was born February 13th, 1956 in De Soto, Missouri to Betty Lea Nixon and Jeremiah "Jerry" Nixon. He graduated from the University of Missouri earning both his Bachelor of Arts in Political Science and his Juris Doctor degree.

Nixon practiced law in De Soto after school when in 1986 he was elected to the Missouri Senate. He was reelected in 1990.

In 1992, Nixon was elected Missouri's Attorney General. He served in that role for four terms until 2009. He oversaw the state's involvement in court settlements that ended mandatory urban busing in the St. Louis and Kansas City public schools.

Nixon became Missouri's 55th governor by winning the 2008 and 2012 gubernatorial elections. During his term Nixon dealt with economic challenges brought on from the Great Recession, the Ferguson unrest, and disaster response including the EF-5 tornado that struck Joplin in 2011.

After his terms in office, Nixon moved to St. Louis and joined the Dowd Bennett law firm. He lives in University City since with his wife Georganne. Nixon has two sons, Jeremiah and Will.
