# Oaths of Office, 1843-2025

Arrangement: By official and non-official until 1986 and thereunder chronological

#### Scope and Content

Oaths of office are as the name implies. After being elected, candidates take an oath to uphold the Constitution of the United States and also to abide by the laws of the state of Missouri and to uphold the standards to which they were elected. This series also includes oaths of non-elected officials. Most recent oaths of office for appointments made by the governor are now found in the series *Gubernatorial Appointments*.

Oaths of office for Capitol Police appointed by the Director of Public Safety are generally found here as non-gubernatorial appointmentes, as are those for the Water Patrol, which merged with the Highway Patrol in 2011. However, some non-gubernatorial oaths of office for Department of Revenue and Social Services staff are found in the series *Gubernatorial Appointments*.

From 1843 through 1986, the series is grouped by officials (boxes 1–5) and non-officials (boxes 6–9). Within groupings, they are arranged chronologically and thereunder alphabetically. The years, or range of years, may designate either the election year or the years to be served. After 1986, the series is no longer grouped by official or non-official but simply arranged chronologically and thereunder alphabetically. Because some oaths are held and sent together, such as those for the Water Patrol or Capitol Police Officers, there may be a large span of years in one folder.
