This series consists of revised departmental plans filed as required by Section 1.6(2) of the Omnibus State Reorganization Act of 1974.

According to that act, "...the head of each department is authorized to establish the internal organization of the department and allocate and reallocate duties and functions to promote economic and efficient administration and operation of the department. A departmental plan shall be developed by the head of each department and approved by the governor in accordance with the transfer by type provided in this act. A plan of such organization with any subsequent changes shall be filed with the secretary of state in the manner in which administrative rules are filed, and copies of the plan shall also be filed with the commissioner of administration and revisor of statutes, and such plans shall be published in an appendix to the revised statutes of Missouri and supplements to the revised statutes."

Files may contain transmittal letters, summaries, plans, organizational charts, and executive salary schedules.
