Historical and Biographical Notes

According to the *Official Manual of the State of Missouri*, the Missouri Horse Racing Commission (MHRC) was created as part of the Department of Revenue by the Article III, Section 39(c) of the Missouri Constitution, approved by votes on November 6, 1984. The MHRC consisted of five governor-appointed members serving five-year terms.

Powers granted to the commission included the ability to license racetracks, regulate races, and regulate wagering.

1985 saw the first legal battle to establish horse racing in Missouri. *Jeff J. Barnes v. Wendell Bailey, et al.* (SC 67631) claimed that horse racing was in conflict with the lottery amendment. The Cole County Circuit Court upheld that the racing was constitutional. The Supreme Court of Missouri affirmed that decision on February 19, 1986.

In 1986, the MHRC granted the Missouri State Fair the first license for pari-mutuel wagering to conduct 15 days of Standardbred harness racing. The following year the Sedalia Horse Racing Association was given a license to conduct 31 days of pari-mutuel harness racing at the Missouri State Fairgrounds. 1988 saw the last year of races at the fairgrounds.

From 1987 to 1994, the MHRC reviewed track applications and worked to establish further legislation on wagering. Other than the races at the Missouri State Fairgrounds, no operational licenses were granted despite eleven track applications. The commission also tried to establish a breeder’s fund within the state. Most additional proposed legislation failed in House or Senate votes. 1992’s Amendment 3 to allow off-track wagering was voted down by Missouri citizens during the November election. A 1994 vote in the Missouri House to allow off-track betting and the creation of a track fund also failed. These last two votes effectively ended horse racing in Missouri.

In 1995 the commission’s duties were merged into the Missouri Gaming Commission, a part of the Department of Public Safety (HB 574). However, the section approving horse racing still exists within the Missouri Constitution, so there is potential of reviving the MHRC.

Year	Event
1984	The Missouri Horse Racing Commission (MHRC) was created by the Article III, Section 39(c) of the Missouri Constitution, approved by voters on November 6, 1984.
1985	<i>Jeff J. Barnes v. Wendell Bailey, et al.</i> (SC 67631) was filed in the Cole County Circuit Court and the pari-mutuel racing amendment was ruled constitutional. The Missouri Supreme Court upheld the Cole County Circuit Court decision on February 19, 1986.
1986	The Missouri State Fair was granted the first license for pari-mutuel wagering and conducted 15 days of Standardbred harness racing from August 12 to September 1, 1986.
1987	The Sedalia Horse Racing Association was given a license to conduct 31 days of pari-mutuel harness racing from July 24 to September 7, 1987, at the Missouri State Fairgrounds.

Year	Event
1988	Final year races were conducted at the Missouri State Fairgrounds from August 12 to October 16, 1988.
1991-1992	HJR 17 was passed in the legislature to offer off-track wagering, but was voted down as Amendment No. 3 in the general election by Missouri citizens on November 3, 1992.
1994	HJR 54 proposed amendment to create off-track wagering opportunities, establish a track fund to build racetracks, and fund the breeder's fund, but the resolution failed in the House and proceeded no further.
1995	Duties of the Missouri Horse Racing Commission were transferred to the Missouri Gaming Commission on August 28, 1995 (HB 574).
