Historical and Biographical Notes

Kenneth Joel Rothman was born in St. Louis on October 11, 1935 to Herman Rothman and Anna Ollanick. After graduating from Soldan High School, he earned both his bachelor of arts in history and political science and law degree at Washington University. Rothman also served in the Missouri Air National Guard from 1953-1962, including serving on active duty in Europe during the Berlin Crisis of 1961. From 1959-1961, Rothman served as the prosecuting attorney for St. Louis County. He was elected to the

Missouri House of Representatives in 1962 at the age of 26, making him one of the youngest elected to the Missouri General Assembly. He represented the St. Louis suburb of Clayton (District 8 from 1963-1967, District 36 from 1967-1973, and District 77 from 1973-1981).

During his eighteen years in the Missouri House, Rothman became the first Jewish person to become House Majority Leader (1973-1976) and Speaker of the House (1976-1980). He also served as chair of the House Judiciary Committee for six years. According to the *St. Louis Jewish Light*, Rothman led "the legislative process and influenc[ed] passage of bills on such issues as the statewide criminal code law, revision of the state drug code, prevention of child abuse, strong licensing standards for nursing homes and a major reorganization of the state's highway and transportation system and structure." Concurrent to his time in the General Assembly, Rothman worked for a private law practice.

Rothman served as Lieutenant Governor of Missouri from 1981-1984. He was also the first Jewish person to serve in a statewide office. Rothman ran as the Democratic nominee against Republican John Ashcroft for Governor in 1984, but lost the race. After this, Rothman returned to private practice.

Rothman married his first wife Geraldine "Geri" Jaffe on April 10, 1965. They had four children, David, Sarah, Rachel, and Daniel. Geri Rothman-Serot also had political aspirations and ran against Kit Bond for the United States Senate seat in 1992. They later divorced and Rothman married Judith Kriegshauser. Rothman passed on April 26, 2019.
