## Historical and Biographical Notes

Governor Mel Carnahan created the Missouri Board on Geographic Names in 1995 via Executive Order 95-28 to coordinate place-naming activities among local, state, and federal agencies. The board reviews all proposed geographic feature name changes and makes recommendations to the U.S. Board on Geographic Names for approval and inclusion in the Geographic Names Information System database (<https://www.usgs.gov/us-board-on-geographic-names/domestic-names>). MOBGN was codified into law in 2009 by Senate Bill 480 and updated in 2018 with Senate Bill 843. Reports are submitted annually to the general assembly.

The current board has 19 members. These include the Secretary of State, director of the Missouri State Archives/State Archivist, executive director of The State Historical Society of Missouri and designees from the Departments of Transportation, Conservation, Natural Resources, Agriculture, and Office of Administration. The United States Geological Survey, United States Forestry Service, and the United States Corps of Engineers provide federal representation. The remaining eight members are citizens appointed by the Secretary of State to serve three-year terms. Additionally, one employee of the office of the Secretary of State serves as the executive secretary for the board to maintain records, including correspondence. The board meets at least once a year.
