# **Historical and Biographical Notes**

Missouri Supreme Court Operating Rule 8 governs the records retention policy of court records for all levels of courts in Missouri. It outlines what items are to be retained permanently and the retention periods of various record types that are slated for destruction. For items to be microfilmed for permanent storage, rules about quality control and maintenance are included. For items saved as paper, there are steps outlined

to deal with potential disasters, including involving the Missouri State Archives (MSA) in making determinations about what records can be saved.

According to the original rule adopted on May 10, 1983, before the courts could destroy records they had to be first be offered to MSA in writing. The letter needed to include the types of cases and the period of time in which the case occurred. If records were not accepted by MSA, then they could be offered to a local society, museum, or library for genealogical study before they could be destroyed.

A revision effective January 1, 2010, amended Rule 8 to remove the requirement to offer short-term municipal court records and non-probate associate court cases to MSA. This change was made at the request of MSA due to the regular rejection these types of records.

A revision to Rule 8 happened in 2018. Starting on July 1, covered records could be transferred to MSA after being purged of non-permanent and extraneous material. Historically significant records that would otherwise be considered short-term were also eligible for transfer after consultation with MSA. The revision also included the provision that all court cases pre-1900 were eligible for preservation.

This collection contains the administrative records of MSA in regard to Rule 8, including the offer letters and transfer forms offering records to MSA and copies of MSA's response declining the records. Responses regarding offer letters accepted are not included as part of this collection and can be found in MSA's accession files.
