Historical and Biographical Notes

The Records Services Division of the Secretary of State's Office originated in 1965. Then-State Representative Alex Petrovic was concerned about the condition and accessibility of state government records, especially after a December 1963 fire in the Jefferson Building in Jefferson City resulted in over \$100,000 in damage. At that time, state agency records were stored all over Missouri, there were no effective retention schedules, and inefficiency was costing the state substantial amounts of money.

Representative Petrovic advocated for a centralized records storage facility, retention schedules, and efficient management and preservation of Missouri's records. The General Assembly approved Petrovic's House Bill 294 in 1965 with an emergency clause (*Laws 1965*, p. 233).

The bill's stated purpose of the new Records Management and Archives Service, which would be part of the Secretary of State's Office, was "for the efficient and economical application of management methods to the creation, utilization, maintenance, retention, preservation, and disposal of official records." Robert F. Connor was hired as the first Director of Records Management and Archives Service, and work began at once to gather records from the various agencies, boxing and inventorying, and transferring them to a new centralized records center. This was followed by Local Records Act passed in 1972 (Senate Bill 376) which enabled state employees to aid county, city, and other local officials to create records retention schedules of their own (*Laws 1972*, p. 642).

The State Records Center opened in a rented warehouse on 1101 Industrial Drive, Jefferson City. In its first year of operation, the Records Center saved the State of Missouri an estimated \$500,000. Additionally, the general public benefitted through the growing ease of requesting records. However, less than a decade later, the Records Center had outgrown its space and moved to 1001 Industrial Drive in March 1974. Another decade passed and the Records Center was fast running out of room again; records from state agencies were being stored in the Records Center at ever-increasing rate.

The General Assembly appropriated funds for a brand-new building that would house all aspects of the Secretary of State's Office, including Records Services. In September 1991 the James C. Kirkpatrick State Information Center opened at 600 West Main Street with state-of-the-art space built especially for Records Services.

Records Services is broken into three subdivisions all led by the Director of Record Services: the Missouri State Archives, the Local Records Program, and Records Management. Over time each division has had their own directors who answer to the Director of Records Service and some management positions are also reflected in this finding aid. The duties of each division are described below.

Missouri State Archives:

The Missouri State Archives (MSA) preserves and makes accessible Missouri's permanent government records from the territorial period to the present. Records are stored on-site in the State Information Center in the form of paper, audio-visual, microforms, and digital. MSA holds records from all branches of state government and is a state documents repository. It also holds some federal records concerning Missouri (census and military records) and microfilmed copies of local and county government records for Missouri. As a public institution, MSA's primary researchers are genealogists, historians, lawyers, and inmates. Fourth-graders from around the state tour the Archives every spring and participate in a program called Archives Alive! In 1984, with the inception of Supreme Court Operating Rule 8, the Judicial Records Project at the Missouri State Archives began. Under this, microfilming of probate and circuit court records was offered. Because of increased patron use, in FY1985 the Archives' visiting hours were expanded to include Saturdays; two years later Thursday evening hours were added. A Friends of the Missouri State Archives organization was formally organized in 1989. The Friends group helps fund a monthly speaker series and some projects for the Archives. MSA is also the primary manager for a website called Missouri Digital Heritage (MDH), which was launched in 2008. MDH makes records from various institutions across the state accessible online, serving as a gateway to Missouri history. The site is nationally recognized.

Records Management:

The Records Management (RM) Program provides state agencies with storage and retrieval as well as destruction for records whose retention times have been met. RM helps state agencies create and maintain their records retention schedules. Records Management also oversees Records Services' imaging department. Microfilming of records began in December 1968 and continues for preservation and disaster recovery to this day. The imaging department also scans images of records to provide better accessibility. The State Information Center features a stainless-steel temperature and humidity-controlled microfilm vault for original silver microfilm negatives. A similar off-site location in southern Missouri stores copies for disaster recovery. Today, Records Management oversees an off-site records center annex on Scruggs Station Road in Jefferson City to accommodate the overflow of non-permanent records.

Local Records:

In July of 1989, the Local Records Program was more firmly established with the passage of House Bill 786 (*Laws 1989*, p. 419). The new LR Program started in July 1990 and a few months later began taking applications for grants from local governments to aid in the preservation of their records. LR is also the home of the Conservation Lab, the only state-funded lab of its kind. Conservators use the lab to protect Missouri's historic documents by providing chemical and physical treatments to repair and preserve paper records.

Scope and Content

Pauline Irvine served as State Archivist from 1967 until 1977. According to her 1993 obituary, Irvine was an education major at the University of Missouri and previously taught social studies in Windsor, Missouri. Irvine's first project as State Archivist was to inventory the Spanish Land Grant records, including writing a guide to the collection and overseeing their microfilming. Over the subsequent years, Irvine processed over 300,000 documents with a focus on land records and governor's correspondence covering 1823-1940. In 1980, Irvine became the curator at the Cole County Historical Society in Jefferson City.

Gary R. Kremer, 1987-1991

Scope and Content

Gary Kremer served as State Archivist from 1988 until 1991. Kremer earned his doctorate in history from American University in Washington, D.C. Prior to serving as State Archivist, Kremer taught history at Lincoln University in Jefferson City from 1972-1987. After leaving the Missouri State Archives, Kremer returned to teaching at William Woods University where he remained until 2004. Starting in 2004, Kremer became the Executive Director of The State Historical Society of Missouri. He also serves as an adjunct professor of history at the University of Missouri, regularly travels the state to give presentations for the State Historical Society and about books he has published, and serves the Friends of the Missouri State Archives Board. In addition, Kremer served or currently serves on numerous boards and commissions including the Missouri Historical Records Advisory Board, Missouri Board on Geographic Names, Missouri Historic Preservation Advisory Council, and Missouri Humanities Council Speaker's Bureau.

During his tenure as State Archivist, Kremer was instrumental in applying for the Missouri State Archives' first grant for the genealogy and local history program Connecting Links (see RG5.55 Missouri Historical Records Advisory Board for the grant application and presentation materials). He also worked closely with then Secretary of State Roy Blunt, who was also a former high school and college history teacher, on many projects.

Kremer has published extensively. In addition to numerous articles, he has written and/or edited a dozen books. These include: George Washington Carver: In His Own Words; James Milton Turner and the Promise of American: The Public Life of a Post-Civil War Black Leader; Missouri's Black Heritage, Race and Meaning: The African American Experience in Missouri; George Washington Carver a Biography; A History of Missouri: Volume IV, 1875-1919; Women in Missouri History: In Search of Power and Influence; A Dictionary of Missouri Biography, A History of Missouri, 1875-1919; Exploring Historic Jefferson City; Heartland History: Essays on the Cultural Heritage of the Central Missouri Region (3 volumes; a compilation of articles originally published in the Jefferson City News Tribune); The Place of Promise: A Historians Perspective on 200 Years of Missouri History.

Lynn Morrow, 1990-2013

Extent: 3 folders

Scope and Content

Lynn Morrow served as the director of the Missouri State Archives Local Records Preservation Program for 22 years. He graduated from Southwest Missouri State University (now Missouri State University) with both bachelor and master degrees in History. Morrow first served as the research historian for the Center for Ozark Studies from 1977 to 1982 before opening his own historic preservation consulting firm from 1983 to 1990. Upon the creation of the Missouri State Archives' Local Records Program in 1990, Morrow became the first director.

Throughout his career, Morrow has published extensively on the history of Missouri and the Ozarks. In addition to writing numerous journal articles, Morrow has co-written or co-edited Connecticut Yankee in the Frontier Ozarks: The Writings of Theodore Pease Russell, The White River Chronicles of S. C. Turnbo: Man and Wildlife on the Ozarks Frontier, Shepherd of the Hills Country: Tourism Transforms the Ozarks, 1880s-1930s, and A Dictionary of Missouri Biography. On the latter, he was the most prolific contributor. Morrow also edited of The Ozarks in Missouri History: Discoveries in an American Region.

Scope and Content

Kenneth Winn, who served from 1991 until 2007, was the first person to hold both the roles of State Archivist and Director of Record Services. Prior to this, Winn served as the resident historian, journal editor, and publications director at the Missouri Historical Society and as a professor at Washington University, where he also received his doctorate in history. During his tenure as State Archivist, Winn focused on historical research. He also served on numerous boards and commissions including the Lewis and Clark Bicentennial Commission, Missouri Historical Records Advisory Board, Missouri Board on Geographic Names, Second State Capitol Commission, Missouri Conference on History, Missouri Center for the Book, and the Council of State Historical Records Coordinators (COSHRC; Chair circa 1998). Additionally, Winn was the archivist who oversaw the move of the Missouri State Archives into the Kirkpatrick State Information Center. After leaving the State Archives, Winn went on to be the Director of Library Services and Public Education at the Supreme Court of Missouri.

Before, during, and after his time as State Archivist, Winn published extensively. He regular wrote articles for historical and law publications, many of which focused on the Mormons in Missouri. During his tenure as State Archivist, Winn edited and wrote entries for the *Dictionary of Missouri Biographies* along with former State Archivist Gary Kremer and historians Lawrence O. Christensen and William E. Foley. He also penned introductions for books, such as Jean Carnahan's *If Walls Could Talk*, was instrumental in the publication of *The Atlas of Lewis and Clark in Missouri* by James D. Harlan and James M. Denny, and served as the consulting editor of *The Art of the Missouri Capitol: History in Canvas, Bronze, and Stone* by Bob Priddy and Jeffrey Ball. Winn's other books include *Exiles in a Land of Liberty: Mormons in American* (author), 1830-1846 and Missouri Law and the American Conscience: Historical Rights and Wrongs (editor), A New England Abolitionist Visits St. Louis (author).

Series contains records pertaining to research projects, exhibits, daily operations, grants, and terms of service on various boards, including the Lewis and Clark Bicentennial Commission, Missouri Historical Records Advisory Board, and National Frontier Trails Museum. Winn's subject files also include items from his predecessors' projects that were continued by Winn and Archives staff. Much of Winn's correspondence, both letters and printed e-mails, are filed topically with other relevant items in these files. Some meeting minutes are also filed as part of this series, but full sets can be obtained in the board or commission's own record group.

Winn's records also reflect others employed at the same time, such as Lynn Morrow, Shelly Croteau, and Stuart "Stu" Dunkle. Often, Winn's copies are the only items remaining from these exchanges. For the Bekki Cook administration as Secretary of State, there is a subset of files titled "Vision Thing" which include general updates from all divisions within the Office of the Secretary of State.

Winn was heavily involved in the Lewis and Clark Bicentennial Commission (1998-2007) and his papers reflect this. Often, they contain items not found in the Lewis and Clark Bicentennial Commission Record Group (RG 391), such as full sets of minutes for the Education Task Force and Agencies Task Force. Some folders for full commission meetings minutes contain the original completed set of packet items which are not reflected in RG 391. Additionally, six grants exist in Winn's files in expanded forms that include cover letters along with the application packet.

The St. Louis Circuit Court Project began under Winn's tenure as State Archivist and his subject files contain numerous files pertaining to the program (All files start out St. Louis Circuit Court, but alternate between "Project" and "Program."). Since its inception in 1999, this project sought to provide access to the millions of documents created by the St. Louis Circuit Court from 1787 until 1875. In 2000, this work was designated an official project of the Save America's Treasures initiative. Work on this project included processing, conservation, microfilming, and digitization. Work was aided by staff at the Missouri State Archives-St. Louis and interns from universities in St. Louis. The most significant cases found in these records were freedom suits including several cases initiated by Dred and Harriet Scott for their freedom.

Winn's subject files also contains files related to the Friends of the Missouri State Archives ("Friends" in his folder titles). These include records regarding fundraising, meetings, and the reorganization of the Friends group circa 2005. Other files of interest involve the replevin case from 1994, which details the state records seized from an auction in Rolla and the subsequent court case. Also included is Winn's research into the act and history of replevin.

Note that the State Capitol Commission ("Second Board," not to be confused with the 1911-1924 version), Second State Capitol Commission, and Missouri State Capitol Commission were all names for the same organization at various times over the years.

Some records are restricted due to the inclusion of social security numbers, blueprints (<u>RSMO 610.021 (19)</u>), or personnel files (<u>RSMO 610.021</u>). Redacted copies of partly open records will be provided to researchers.

Shelly Croteau served as the Assistant State Archivist from 1993 to 2021. In this role, she served as the Missouri State Archives fiscal agent, overseeing grants and internships. She also supervised processing and education staff. Prior to working at the Archives, Croteau served as a Latin instructor and public school teacher and as a manuscript specialist at the University of Missouri Archives. During her tenure she taught public history courses at Lincoln University and William Woods University. Her oversight of the regional National History Day in Missouri competitions, including incorporating virtual competitions prior to COVID, were innovative and copied across the state. Throughout her career, she was active in several archives and historical associations, often serving on the boards, including the Missouri Association of Museums and Archives, and the Academy of Certified Archivists.

John Dougan, 2007-

Scope and Content

John Dougan has served as Missouri's State Archivist and Director of Record Services since 2007. Prior to this appointment, Dougan earned a Master's in History from the University of Memphis, taught social studies, spent eight years in various library and archives roles at the Memphis-Shelby County Public Library and Information Center, and served nearly eight years as the archivist and records manager for the Shelby County Archives in Memphis, TN. In the latter role, Dougan oversaw daily operations, streamlined the retention schedules, and helped create an online records portal. In his current role, Dougan oversees all Records Services Division operations including processing, reference, records management, imaging, and local records. During his tenure a focus was placed on better digital access and improvement to reference and preservation services. He was instrumental in the creation and maintenance of Missouri Digital Heritage, Missouri's online records portal and the additions of several online databases with upgrades and major additions to the existing databases. An online indexing portal for death certificates was begun in and completed in 2011 to increase indexing efficiencies by the Archives online volunteer group while From the Page and FamilySearch were used for remote indexing other projects including the Missouri Slave Census Schedules and Missouri Marriages. He also oversaw the shift to digital equipment in the State Imaging Lab and the creation of the Records Center Annex.

Dougan serves on the Missouri Historical Records Advisory Board, Missouri Board of Geographic Names, Local Records Board and State Records Commission in addition to a support role for the Missouri State Capitol Commission. He has previously served on the boards for the Missouri Civil War 150 (2010-2015), Missouri Bicentennial Commission (2017-2021) and for the Council of State Archivists (COSA; 2016-2021, including serving as COSA president in 2019-2020.

Note that the State Capitol Commission ("Second Board" on other finding aids, not to be confused with the 1911-1924 version), Second State Capitol Commission, and Missouri State Capitol Commission were all names for the same organization over the years.
