HISTORICAL AND BIOGRAPHICAL NOTES

Born January 28, 1946, in Dayton, Ohio to Thomas Dunbar Graham and Christine (Wood) Graham, Christopher Graham (Thomas Christopher Graham) served in the Missouri House of Representatives from 1983-1990. He attended Jefferson City, Missouri public schools as well as the Lawrenceville School in Lawrenceville, NJ. As the

son of Missouri State Representative and Speaker of the House, Thomas D. Graham, Christopher "watched the legislative process in action" while growing up (*Jefferson City News Tribune*, May 15, 1983.) He completed his education at the University of Missouri-Columbia (B.S., Business Administration, J.D.) and Georgetown University (LL.M., Taxation). Graham married Marsha Carol Gum on August 24, 1968, and they had three daughters, Christiana, Elizabeth, and Margaret.

Prior to his work as a State Representative, Graham was a Law Clerk to Judge J. P. Morgan of the Missouri Supreme Court from 1971 to 1972. He began working as an attorney in 1973 (*Jefferson City News Tribune*, November 19, 1978) and he and his father were partners at the Graham & Graham law firm in Jefferson City. He was City Attorney of Jefferson City from 1977 to 1981. Christopher Graham also served in the U.S. Army. He was a Colonel in the Judge Advocate General Corps of the Missouri Army National Guard. Graham was also active in the local Jefferson City community, including as a member of the First Assembly of God Church.

In 1982, Graham was elected Representative for Missouri House District 112, serving a portion of Cole County that included Jefferson City. He served a total of four terms. Graham defeated Republican Paul D. Schleer for this position left open by Jim Strong. The seat had been held previously by his father until his retirement. Christopher Graham did not face Republican opponents in his 1984, 1986, or 1988 campaigns for the same. In 1990, Graham ran for the Missouri Senate 6th District seat. He defeated Missouri State Highway Patrol Lieutenant, George S. Grazier, for the 1990 Democratic nomination, but lost the race to Republican Larry Rohrbach.

Graham served as Chair of the Interim Committee on Salaries and Benefits of State Employees (appointed by Speaker of the House Bob F. Griffin in October 1988.) Graham led the Committee in looking at "all areas of compensation and benefits, especially the state medical care plan in light of recently announced rate hikes." He explained that, "Our government salaries have not kept pace with other public and private sector wages, which average 16 percent higher. To be a good employer, the General Assembly recognizes the need to ensure that benefits are adequate and equitable." (Missouri House of Representatives News Release: House Interim Committee Studies State Employees,
October 7, 1988.) Some of the committee's recommendations included within-grade pay increases, improvements to the Missouri State Employee's Medical Care plan, a uniform classification and pay plan for all of Missouri state government departments, an incentive pay plan, and the establishment of a salary and benefits commission.

Graham was Chair of the Joint Committee on Administrative Rules during his final term. He was the Vice Chair of the Ways and Means Committee from 1985-1986 and Vice Chair of both the Judiciary Committee and Workers' Compensation Committee from 1987-1988. Graham also served on the Appropriations Committee and the Judiciary Committee throughout his tenure. Graham served on the Banks and Financial Institutions Committee during his latter three terms and on the MOSERS (Missouri State Employees' Retirement System) Board of Trustees, among other service commitments.

According to his 1990 Senate campaign ads, Graham's legislative accomplishments include:

- Protection for senior citizens against reduction or loss of state assistance payments due to property tax assessment
- The Equal Access to Justice law, which protects small businesses from certain legal actions by state agencies
- Better pay, working conditions, and benefits for state employees
- Uniform pay classification for state employees
- Protection for merchants against frivolous lawsuits by shoplifters
- A criminal tracking system to help law enforcement keep watch on parolees
- The Video Justice law, allowing inmates to have legal proceedings by closed-circuit television
- A uniform code of military justice for members of the Missouri National Guard
- Better retirement and health care for teachers
- Better retirement for Lincoln University employees
- Major reforms for avoiding probate

Following his service in the Missouri House of Representatives, Graham worked as legal counsel to the Missouri State Auditor, as Assistant Attorney General, as Commissioner of the Administrative Hearing Commission, as well as an Administrative Law Judge for contested matters related to the regulation of the state's surface transportation industry. He also served as the State Judge Advocate and Ethics Counselor in the Missouri National Guard, retiring after 30 years of service with the rank of Colonel, JAGC.

Scope and Content

These are Graham's legislation-related records, largely concerning bills that he introduced or co-sponsored. This is not a complete representation of his work since some years and legislation are not available.

The House Bill (HB) files document Graham's work on various bills. Graham applied topical labels to these files and sometimes also noted his co-sponsorship or a committee that considered the bill. The files typically contain various official versions of the bills in progress, sometimes with handwritten edits or notes. Fiscal notes, routine legislative correspondence regarding the progress of the bill, vote counts, and Graham's correspondence with the Governor's Office regarding his bill signing attendance are also found. Related documents in the files include news clippings, correspondence to and from constituents, and reviews by attorneys.

House Resolutions files include materials related to House Courtesy Resolutions and House Concurrent Resolutions that Graham introduced during each Session. They often contain the text of the final Resolution, related clippings, correspondence, and Courtesy Resolution forms. There are also two House Joint Resolution (HJR) files containing copies of the final text, clippings, and correspondence.

Graham retained Governor-signed copies of some of the bills he worked on during the Second Session of the 84th General Assembly (1988) and the First Session of the 85th General Assembly (1989.) There are also a few folders of Co-signed bills, Amended Bills, and one folder containing correspondence on SB 711, relating to private road access.

CAMPAIGN FILES, 1981-1990

Scope and Content

These records were created as part of Graham's campaigns for the Missouri House of Representatives 112th District seat and the Missouri Senate 6th District seat. Many of the files are related to Graham's publicity and political ads or campaign products (e.g., brochures and novelties.) The files also document the development of the "Graham cracker" novelties and include nail files and bumper stickers in his signature bright yellow and black campaign colors. Additionally, Graham gathered news clippings, campaign products, and research regarding other candidates, particularly relating to political opponent, Larry Rohrbach. There are many notes by or between Graham and his staff throughout many of the files.

Several files are related to fundraisers, receptions, and other events or functions attended or organized by Graham as part of his campaigns. Political topics and criticisms are reflected in Candidate questionnaires, General Election issue research, News Releases and Mailings, and various information and research files. There are records surrounding political contributions, including within the Labor unions and Lobbyist files. The records also highlight campaign strategy and the activities of campaign workers and volunteers.

During his 1990 Senate campaign, Graham hosted Czechoslovakian Delegates at the American Council of Young Political Leaders U.S. Democracy Conference/ Election Study Tour, from November 1 to November 9, 1990.

Scope and Content

This series reflects Graham's work on several committees, though not all of his committee assignments are represented. The files contain routine legislative communication regarding bills as well as constituent correspondence regarding particular issues and bills with Graham's responses. Copies of bills, meeting schedules, testimony, newsletters, newspaper clippings, state government documents, and other research related to the committees' work also appear.

The majority of the records surround the work of the Interim Committee on Salaries and Benefits of State Employees. The records include audio and written records of testimony before this committee and several committee reports. Graham gathered various state documents (studies and annual reports) related to his work on this committee.

CORRESPONDENCE, 1982-1990

Arrangement: Alphabetical by file topic and thereunder chronological. Ordered by date of Graham's response, date received, or date of original letter, depending on availability.

Scope and Content

These records are incoming and outgoing correspondence, primarily with constituents. The majority are categorized as Constituent complaints and Constituent remarks. Constituent complaint letters contain disagreements with Graham's legislative stance or contain requests for his assistance with specific issues. The letters are often filed with a copy of the letter Graham sent on the constituent's behalf. Constituent remark letters contain comments on legislative topics or specific bills. There are also a large number of anti-abortion letters from constituents from 1990.

Graham also received many letters requesting recommendations for employment, particularly within state government. Recommendation letters are often filed with a copy of Graham's outgoing recommendation letters and related resume. There are a few applications for employment in Graham's office and recommendations for appointments to state government positions.

Additionally, there are files with incoming and outgoing congratulations letters and thank you notes. There is a small file of correspondence categorized by names starting with "T" and a small file on reassessment of apartment buildings, both from 1983-1985. No other alphabetical correspondence files or topical correspondence files were received at the collection's donation.

NEWS PUBLICATIONS, 1978-1990

Arrangement: Chronological

Scope and Content

This series mostly comprises of newspaper issues, newspaper clippings, and a few magazine articles collected by Christopher Graham. Some materials, such as the *Jefferson City News Tribune*'s Women's section may have been collected by others such as Graham's wife, Marsha Graham, or staff members, Marilyn Schmutzler or Kathy Lee Tolson. Marilyn Schmutzler's involvement in the Cole County Legal Secretaries Association is highlighted in this section.

The majority of the records are issues of the *Missouri Times* and clippings from the *Jefferson City News Tribune* or *Post-Tribune* leading up to and covering the 1982 election. Some of the topics include election candidates and issues, big trucks on highways (Proposition A), Speaker Bob Griffin's tax package, and raising the cigarette tax for education. The Jefferson City School District newsletter (*The State of Learning in the Jefferson City School District*), the *Jefferson City News Tribune*'s Women's section and political editorials, and local event clippings also feature prominently. There are a few other publications covering topics of interest such as year-round schools, President Reagan's school prayer amendment, and support for the developmentally disabled. These publications include the *Autogram-Sentinel Iberia News, Bear Facts* (Missouri National Guard), *Daily Capital News, Family Weekly, The Forerunner* (Marantha Campus Ministries International), *Fort Lauderdale News/ Sun-Sentinel* Business section *Government Executive* magazine, *Governing* magazine, *Insight* magazine, *Miller County Autogram-Sentinel*, *Missouri Catholic Conference Messenger, Mizzou, The Statesman*, and the *St. Louis Post-Dispatch*.

A draft of Marsha Graham's letter to Annie and John Glenn (1984 presidential candidate) is included with a *Family Weekly* article on Annie Glenn, published May 15, 1983.

Scope and Content

This series contains a mixture of subject-related correspondence, newspaper clippings, articles, and other ephemera. Many of the files are related to topics of legislation or concern such as abortion, Jefferson City, Lincoln University, or workers' compensation. Constituent letters (otherwise known as remarks) are sometimes included. There are a large number Missouri state government department files, often containing correspondence with department heads. Other files are related to events such as John Ashcroft's Leadership Conference or prayer breakfasts. There are also records documenting the work of Graham and his office such as his Legislative questionnaire, Speeches, the Freshman Legislators Tour, and Tours (mostly organizing school tours.)

A sizable portion of the files relate to Lincoln University's state of financial exigency, resignations of the Board of Curators and President, and the state of Missouri's response. These files include correspondence between Graham and then-Lincoln University President, Thomas Miller Jenkins, Commissioner of Higher Education, Sheila Avery, students, faculty, alumni, and other stakeholders.

Some of Graham's work as a Judge Advocate General is documented in National Guard related files. Incoming and outgoing personal letters are also available, as are Graham's letters with US Senator Thomas Eagleton, US Representative Ike Skelton, and US Senator Jim Strong. There are also a large number of loose records intended for a scrapbook.
