## **Historical and Biographical Notes**

Annette Nobel Morgan was born Aug. 31, 1938, in Kennett, Mo. to John and Alletha Bradley Noble. She earned a Bachelor of Arts from University of Missouri–Columbia and a Master's Degree from the University of Missouri–Kansas City. She married William B. Morgan in 1961. They had two children, a son and a daughter.

Annette Morgan was first elected to the Missouri House of Representatives from District 29 in 1980. She was elected from District 41 in 1982 and served as its representative until 1992. In 1992, she was elected to serve from District 39, which she did for two terms, 1993–1996.

An adult educator by profession, she was very active in education issues and served on several national education-related committees, including Governor Kean's (NJ) Teacher Renaissance Working Party of the Education Commission of the States, and the National Advisory Board of Parents as Teachers. Morgan chaired the House Elementary and Secondary Education Committee from 1985 through her final term. Because of her role as chair of this committee, she was appointed co-chair of joint committees and task forces focused on education reform. Other committees that she served on during her legislative career were Appropriations–Education and Public Safety; Rules, Joint Rules, Bills Perfected and Printed; Election; Property Equalization and Classification; Urban Affairs; and Legislative Research. Morgan was a Democrat and active in Democratic campaigns.

Annette Morgan passed away on Dec. 18, 2001.

# Children at Risk in Education – SB 740, 1989–1990

Extent: 0.1 cubic ft.

#### Scope and Content

Senate Bill 740, which was sponsored in the House by Morgan, made numerous changes in the law relating to public schools, school programs and services. Some of the provisions included making college credit available for students still in high school, Braille instruction for all eligible students, the creation of a drug-free schools program, and service to handicapped 3–4 year old children in compliance with the federal preschool grant program. Morgan was outspoken in support of the bill, and there was controversy over an anti-abortion amendment that was tacked onto the bill late in the session. The amendment failed approval.

This series contains constituent letters, correspondence, news clippings and articles, bill summaries, and an audio tape made by Morgan of her thoughts and reflections on the passing of the bill.

# Excellence in Education Act, 1984–1992

#### Scope and Content

A 1983 report from the National Commission on Excellence entitled "A Nation at Risk" centered on the mediocrity of education in the nation. After this report became widely publicized, education reform was foremost in the minds of many state legislatures, and Missouri was no exception. Morgan was appointed to co-chair a joint committee for a pilot project sponsored by the Education Commission of the State and the National Conference of State Legislature and partially funded by a Danforth Foundation Grant. The committee held seminar-style meetings to receive information from the best education experts in the country. The committee addressed four broad topics: testing, incentives for excellence in teaching and schools, teacher preparation, and school finance. Bills were formulated and presented in both houses. House Bill 463, the Excellence in Education Act, was signed into law by Gov. John Ashcroft on May 23, 1985.

This series contains reports, working papers, correspondence, meeting agendas and minutes, notes, speeches, programs from other states, grant manuals, project descriptions and news releases. The majority of the materials relate to the implementation of the Excellence in Education Act rather than its development.

# Outstanding Schools Act, 1991–1996

Extent: 2.1 cubic ft. (5 Hollinger boxes and 1 partial)

#### Scope and Content

After Cole County Circuit Court Judge Byron Kinder ruled the existing school foundation formula to be unconstitutional in 1992, a Joint Education Finance Task Force was appointed by Senate President Pro Tem James Mathewson and House Speaker Bob Griffin to propose a new formula for consideration by the General Assembly. Representative Morgan, the House Education Committee Chair, was selected to co-chair the task force along with Senate Education Committee Chair Harold Caskey. The objective of the Task Force was to develop a new formula that would distribute state money to all districts in the state in an equitable manner. The task force was funded by the Danforth Foundation and the Civil Council of Greater Kansas City, and recruited two nationally recognized education funding experts to help develop the new formula. Senate Bill 380, known as the Outstanding Schools Act, was passed by the General Assembly on the final day of session and signed into law by Gov. Mel Carnahan on May 27, 1993. This bill provided a new foundation formula and additional state funding for education. It also provided for education reforms such as challenging statewide performance standards for students and an assessment system to measure the degree with which students met the performance standards; smaller class sizes; early childhood development programs; vocational education improvements; and more teacher training.

This series contains materials relating to the development and implementation of the Outstanding Schools Act. Included are reports, correspondence, formula runs, meeting agendas and notes, news releases, printed materials, bill versions, court decisions, information from other states, and funding reports.

# Parents as Teachers, 1984–1990

Extent: 0.2 cubic ft.

Arrangement: Alphabetical

#### Scope and Content

The Missouri Department of Elementary and Secondary Education, in cooperation with the Danforth Foundation of St. Louis, implemented the new Parents as Teachers pilot project in four school districts in 1981. Independent evaluation of the project from 1981–1984 indicated the program was a success in terms of student achievement and parental satisfaction. In 1982, a Commissioner's Committee on Parents as Teachers was formed to promote parental involvement in education. This committee supported the enactment of SB 658, the Early Childhood Development Act of 1984, which authorized funding to Missouri school districts for preschool screening, parent education, and programs for preschoolers with developmental delays. The 83<sup>rd</sup> General Assembly appropriated funds for school to offer voluntary Parents as Teachers services, which first began statewide in 1985–1986. Morgan was appointed to the Commissioner's Committee in 1985. A National Parents as Teacher Center was established in December of 1986 in cooperation with the University of Missouri–St. Louis. In March 1987 a Parents as Teachers National Advisory Board was appointed with Morgan among its members.

This series contains materials generated by Morgan's involvement in the Commissioner's Committee on Parents and Teachers and the Parents as Teachers National Advisory Board. Included are reports, newsletters, promotional materials, news articles and releases, speeches, and correspondence.

# **Teacher Renaissance Working Party, 1985–1986**

#### Scope and Content

The Education Commission of the States was formed in 1965 as a nonprofit, nationwide compact formed to help governors, state legislators and others develop policies to improve the quality of education. In September 1985, Gov. Thomas H. Kean of New Jersey, the 1985–1986 chair of this commission, appointed 20 nationally recognized political leaders, educators, and business leaders to a Teacher Renaissance Working Party. Morgan was one of these appointees. The working party was created to strengthen and encourage teachers as professionals and to include their ideas and suggestions in formulating education reforms.

This series represents Morgan's involvement with the Teacher Renaissance Working Party. Included are a briefing book, correspondence, speeches, articles, news releases, and working papers.

# Two-Thirds Majority Vote, 1984–1988

#### Scope and Content

The issue of passing bonds to finance public improvements by a four-sevenths majority rather than the long-standing two-thirds majority was brought up in the legislature for five years before finally being approved and sent to the voters. Morgan sponsored a bill version in the House every year from 1984 until 1988 when the legislature agreed to place the issue on the ballot. Missouri voters ultimately approved the measure.

This series includes materials relating to the efforts to get the four-seventh bill passed in the legislature, such as bill versions, correspondence, reports, witness lists, statements of support, a survey, news articles and news releases.
