Historical and Biographical Notes

Philip M. Barry was born on March 21, 1938 in St. Louis, Missouri. A licensed journeyman plumber and a Democrat, he was first elected to the Missouri House of Representatives from District 105 in 1972 and was re-elected from that district in 1974, 1976, 1978, and 1980. In 1982 he was elected Representative from District 101 and he continued to serve in that capacity through 1990. Barry chaired the Worker's Compensation Committee from 1977 to 1990 and served on a variety of other committees during his tenure as Representative, including: Consumer Protection, Commerce, Labor, Ways and Means, Revenue and Economics, Employment Security and Fair Practice, and Retirement. Barry received the *St. Louis Globe-Democrat* Outstanding Legislator Award, during the 81st General Assembly.

Barry married Joan M. Gildehaus on May 18, 1963, who served as a representative for District 100 from 1996-2000. After leaving office, he was appointed to the Labor and Industrial Relations Commission in 1990. He also served as a business representative for Plumbers Local 35 and Plumbers and Pipefitters Local 562.
