Historical and Biographical Notes

Born July 19, 1943 in Richmond Heights, James N. Riley was educated at Clayton High School, Southeast Missouri State University and Washington University and worked as a licensed journeyman plumber and real estate representative. He married Merry Sandra Milewski on February 27, 1965. The couple had two sons.

Riley, a Democrat, was first elected to the Missouri House of Representatives from District 88 in 1972 and was re-elected every year through 1980. In 1982, he was elected to the House from District 89 and again was re-elected continuously through 1990. The *St. Louis Globe-Democrat* named Outstanding Legislator in 1980.

Rep. Riley chaired the Employment Security and Fair Practices Committee from 1977-1978, the Consumer Protection Committee from 1979-1990, and the Labor Committee during his final term from 1991-1992. He served on several other committees during his tenure as representative, including Local Government and Related Matters, of which he was vice chair in 1975-1976, Revenue and Economics, Urban Affairs, Commerce, and Government Organization. Riley passed away in 2009.
