Numerous gaps exist with this collection:

1. Plans 0001-0009 and 1000-1005 (state employees and educators) were not transferred as part of the 1996, 2002, or 2006 file accessions.
2. Some papers for boxes covering 1998-2000 show they were transferred to the Archives, but they were not located at the time of processing.
3. Most Plan Files for 1998-2004 were incorrectly labeled by the agency and were destroyed between 2010 and 2014 except for one box containing the 2004 plans 0001-1005.

Historical and Biographical Notes

The Joint Committee on Public Employee Retirement was created by Senate Bill 393 (1983 Laws, p. 250) and the committee's first meeting was held later that year. The committee consists of twelve members, six appointed by each the President Pro Tem of the Senate and the Speaker of the House. The committee is required to meet at least once quarterly. The governing statutes for the committee, located in Chapter 21 RsMo (21.550-21.563), give the following duties to the committee:

1. Make a continuing study and analysis of all state and local government retirement systems and report annually to the General Assembly.
2. Devise a standard reporting system to obtain data on each public employee retirement system that will provide information on each system's financial and actuarial status at least biennially.
3. Determine from its study and analysis the need for changes in statutory law.
4. Make any other recommendations to the General Assembly necessary to provide adequate retirement benefits to state and local government employees within the ability of taxpayers to support their future costs.

Acronyms for the Joint Committee on Public Employee Retirement committee over the years include PERS, JPERS, and JCPERS with PERS being the one most commonly used.

Retirement Plans, 1984-

Scope and Content

The Retirement Plans series contains the plan year worksheet for the organization and other relevant items, such as plan terms or investment records.

Chronology for 1984-1993 years was based on the file date, not the actual date for the plans. For 1984-1988, filed and plan dates were the same. For 1989-1993, the filed date was in the next calendar year. Thus, for example, plans under 1993 grouping/file date were actually 1992's plans. Starting with 1993-, numbering reflects the year of the actual plan, not the file date. Thus 1993 in this grouping is actually 1993's plans. The organization change is based on the original labeling of the agency's files.

Files for plan years 1998-2001 and 2005-2006 are missing. However, some information for these years can be found within the collection. Some 1997 folders contain selected information for 1998 and some 2002 folders contain selected information for 2001. These can include a plan year financial summary or the plan terms for the aforementioned year, but never contain the yearly PERS worksheet.

Some plan documents cover multiple plans, but only exist in one plan's folder. This is often not noted in the file. However, these will always be between the same city or county for a given year (ex. Raytown Fire Protection District and Raytown Police).

Note: Restrictions: Some retirement plans contain social security numbers of staff within the plan, which are closed to the public. All folders marked with (Restricted) will need to be reviewed by staff and copies redacted.
