### **Historical and Biographical Notes**

The St. Louis Court of Appeals was created by the 1875 constitution (Article VI Section 12) and its district was limited to St. Louis City, St. Louis, St. Charles, Lincoln and Warren counties. Currently the Eastern District covers 25 counties and the City of St. Louis.

The St. Louis Court of appeals originally had final appellate jurisdiction over all cases of the circuit courts within its district, unless the amount in controversy exceeded \$2500,

involved the construction of the Missouri or U.S. Constitution, validity of Missouri Statutes, revenue laws, title to state office, title to real estate, if a political subdivision or state officer was a party, or felony cases. These cases were appealable to the Supreme Court from 1876-1884. From 1884-1972, these cases were appealed directly to the Supreme Court, skipping the appellate courts entirely.

An 1884 Constitutional amendment (Laws, 1883, p. 215) expanded the jurisdiction of the St. Louis Court of Appeals to 55 counties and the City of St. Louis. All other counties were assigned to the newly created Kansas City Court of Appeals. The amendment also gave the General Assembly the power to create an additional court of appeals and to modify the districts when necessary.

In 1909, the General Assembly created the Springfield Court of Appeals (Laws, 1909, p. 393), adjusting the jurisdiction of the St. Louis Court of Appeals to 31 counties and the City of St. Louis.

In 1978, the St. Louis Court of Appeals was renamed the Court of Appeals – Eastern District (Laws, 1978, p 865) and its jurisdiction was set to 25 counties and the City of St. Louis.

## Timeline

Year	Event
1875	St. Louis Court of Appeals created by the 1875 constitution.
1884	Kansas City Court of Appeals created by constitutional amendment. The General Assembly is also give the authority to create an additional district court in the future.
1909	Springfield Court of Appeals created by SB 97.
1978	Renamed the Court of Appeals – Eastern District by HB 1634.
