Historical and Biographical Notes

The Missouri Well Installation Board was established by Senate Bill 221 in 1991 (*Laws 1991*, p. 754). It is composed of the director of the Department of Natural Resources and eight members appointed by the governor: four public members (at least one public water supply user and one private well user), four members holding valid permits under RSMO 256.600 and 256.640 (two members holding permits as well installation contractors, one member holding permits as a heat pump installation contractor and a well installation contractor and one member holding permits as a monitoring well installation contractor and a well installation contractor).

The board is tasked with administration and enforcement of the Water Well Driller's Act and the Missouri Well Construction Rules 10 CSR 23-3 (*Laws 1985*, p. 650).
