Historical and Biographical Notes

Mining has played a significant role in Missouri's history. In the 1840s, large-scale iron mining and smelting began around Iron Mountain in St. Francois County. From the 1860s to the 1960s, this area was also one of the world's leading producers of lead.

Mined materials such as zinc, copper, and limestone were also important to this sector of Missouri's economy. Coal mining in the state began in the 1840s through southwest and northern Missouri. Such mining went virtually unregulated until 1971. By then, more than 100,000 acres of timber and agricultural land had been affected by mining. As these mines were abandoned, they became an increasing public safety and environmental hazard. Missourians were left with a legacy of acid mine drainage, dangerous highwalls, hazardous water impoundments, dangerous mine openings, barren spoils, coal waste, soil erosion and stream sedimentation.

Missouri enacted legislation in 1971 to offset the effects of mining. Missouri Senate Bill 1 regulated coal, tar sand and barite mining. The same year Missouri House Bill 519 was passed to regulate limestone, sand, gravel and clay pits. The Federal government enacted Public Law 95-87, the Surface Mining Control and Reclamation Act, or SMCRA, in 1977. Shortly thereafter, the Missouri Department of Natural Resources applied for resources to reclaim coal mines in Missouri. In January 1982, the Abandoned Mine Lands section of the Land Reclamation office was formed. This office works in conjunction with the federal government and other sectors of Missouri government to repair the environmental damage caused by mining across the state.

Missouri's first reclamation project was completed in November 1982. The Abandoned Mine Land section has made significant progress in eliminating public health, safety and environmental problems from past mining areas. Most projects in this section have been located on private land and mines are primarily coal related because of federal funding restrictions. Not all abandoned mine lands in Missouri require reclamation, but the Department of Natural Resources continues to offer technical assistance to owners of abandoned coal mine lands.
