### HISTORICAL AND BIOGRAPHICAL NOTES

Wanted posters date back to the beginning of statehood. Wanted posters could come from local county, state or federal officials, private detectives, slave owners, businesses, or private citizens.

Pauly Jail Works was established in 1856 in St. Louis and incorporated in 1885. Its owner and president was P.J. Pauly, Jr. The company constructed prison cells, doors, window bars, iron bunks, etc. out of steel and iron.
