Ginn (1911-2003) served as Prosecuting Attorney for Lawrence County, Superintendent of the Missouri Highway Patrol, served in the military during World War II, worked for the Missouri Book Stores Incorporated (established by his father-in-law and now known as MBI), served on the board of banks, corporations, and more, and was active in the Republican Party.

This collection was donated to the Missouri State Archives in 2020 by Nancy Ginn Martin of Boone County. Martin's parents were M. Stanley Ginn (1911-2003) and Rosemary (Lucas) Ginn (1912-2003). Both Ginns held positions in public and private service. Stanley served as Prosecuting Attorney for Lawrence County, Superintendent of the Missouri Highway Patrol,

served in the military during World War II, worked for the Missouri Book Stores Incorporated (established by his father-in-law and now known as MBI), served on the board of banks, corporations, and more, and was active in the Republican Party. This collection contains items related to his careers and personal life.

Scope and Content

On April 16-17, 1944, the headless bodies of two women were discovered at Lake of the Ozarks. As Superintendent of the Highway Patrol, M. Stanley Ginn investigated. This record series contains photographs from the investigation. **Because of the graphic content of some images, those particular photographs are restricted.**

One month into the investigation, the bodies were identified as mother and daughter Pearl Fairfax, 59, and Mollie Mattie Holland (aka Mattie Mollie), 35*, of La Monte, Pettis County. Holland's husband Edgar Holland was arrested on May 20, 1944 for first-degree murder. He was sentenced in the Pettis County Circuit Court to life in prison. Holland appealed and the Missouri Supreme Court affirmed the lower court's ruling.

**Her death certificate says she is 34, but earlier records point to her being 35, particularly a 1910 census where she is listed as one year old. Some newspapers report 36.*

Scope and Content

These are files from the case State of Missouri vs. Floyd Cochran for the first-degree murder of Marylou Jenkins in Columbia, Boone County, on February 5, 1946. Cochran was found guilty and executed by the state on September 26, 1947. This case is highly controversial because of the nature of Cochran's confession and the question as to whether or not it was coerced by investigators. Cochran was an African-American man and the victim was a white woman.

CASE FILE: STATE OF MISSOURI VS. JAKE BRADFORD, JR. (1949-1951)

Scope and Content

These are public defender M. Stanley Ginn's files on State of Missouri vs. Jake Bradford, Jr., a black man, who was accused of raping a white teenaged girl in 1949. Bradford was found guilty by the Boone County Circuit Court. Ginn appealed the case on his client's behalf to the Missouri Supreme Court where he argued that Bradford's confession was coerced by investigators. The Supreme Court reversed and remanded the case.

Pursuant to RSMo §595.037, public defender files on (2) rape and (3) minor victims are closed records. **Therefore, this record series is CLOSED.** RSMo §595.226 further provides that Missouri court records concerning rape shall be redacted of the victim's name.

CASE FILE: MUELLER VS. POWELL, WEDEMIER AND GINN (1950-1953)

Scope and Content

On the night of March 18/19, 1950, thirteen-year-old Janett Christman was babysitting for the Romack family in Columbia, Boone County. When Mr. and Mrs. Romack returned home, they found her murdered. The Romacks' friend Robert Mueller was implicated in the crime.

Because of his background with two similar cases where he served as lawyer to the defendant (see Bradford Case File) M. Stanley Ginn was brought in to witness the interrogation of Mueller as performed by Sheriff Glenn Powell and Deputy Sheriff Julius Wedemier. At that point, Ginn held an honorary deputy sheriff's commission. Mueller sued the three for a violation of his rights under *habeas corpus*. These documents relate to the *habeas corpus* case, heard by the District Court of the United States for the Central Division of the Western District of Missouri and on appeal to the United States Court of Appeals Eighth Circuit.
