Abstract: Records (1842-2015) of joint, interim, and special committees of the Missouri General Assembly include analyst files, appointments, committee books and minutes, correspondence, hearing records and transcripts, legislator files, reports, and roll calls.

HISTORICAL AND BIOGRAPHICAL NOTES

Special legislative committees—also known as select committees—are called whenever an investigation needs to be made by the General Assembly into a particular area of

government. This may entail investigating one of their own members (e.g., impeachment) or broader governmental responsibilities (e.g., state penitentiary); a topic of public urgency (e.g., Flood of 1993) or public censor (e.g., Rock Festivals); or the effect of specific legislation. Interim committees are created between sessions of the General Assembly. Joint committees are created with members from both the House and the Senate.

The actual placement of joint, interim, and special legislative committee records has been haphazard over the years, often being found in the General Assembly (Record Group [RG] 550). While the traditional opposite to a special committee would be a (permanent) standing committee, which has its own record group (RG 560), that is not necessarily the case. A joint or an interim committee can be a standing committee. Basically, the lines between a special and standing committee may blur. For instance, a committee may be a special or interim (sub)committee of a standing committee, in which case it may be found here or in the Standing Legislative Committees (RG 560).

To further complicate matters, in 2007, Speaker Rod Jetton disbanded many standing committees and reformed them as special committees, so as to have the power to appoint members from the minority party. Suffice to say, a search of all relevant record groups (RGs 550, 552, 555, 560, 561) may be required to find the records of any one committee, if indeed any records have been deposited in the Archives.

From the year 2000, all committee books and minutes transferred by the General Assembly to the Archives have been placed in that record group (RG 550). However, for convenience, all joint, interim, and special committee records found there and in Standing Legislative Committees (RG 560) have been cross-referenced in this finding aid.
