*Abstract:* Records (1962-1973) of Governor Warren Eastman Hearnese (1923-2009), include administrative assistant files, advisory commission on inter-governmental relations materials, appointments, audits, commutations of sentences, depository contracts, disaster records, domestic and foreign extraditions, execution correspondence, general correspondence, legislative files, messages, miscellaneous files, national governors' conference materials, press releases, proclamations, research files, restorations of citizenship material speeches, state department and agencies correspondence, superintendent of school files, audio tape and articles, tax reforms, waivers of extradition, and writs of elections. Also includes a subject index.

## Historical and Biographical Notes

Warren Eastman Hearnese was born on July 24, 1923 in Moline, Illinois to Earle B. and Edna Mae Eastman Hearnese. He went to public schools in Charleston, MO and graduated from the U.S. Military Academy at West Point, New York in 1946. He served with the 35<sup>th</sup> Division, U.S. Army, leaving in 1949 after a medical discharge. Hearnese received a law degree in 1952 from the University of Missouri and practiced law in East Prairie until 1961. He married Betty Cooper on July 2, 1947 and the couple had three daughters.

He was elected to the Missouri House of Representatives as a Democrat from Mississippi County in 1950. Hearnese served in that position until he was elected as Missouri Secretary of State in 1960. Hearnese defeated Ethan A. H. Shepley in the 1964 gubernatorial election and was sworn in as Missouri's 46<sup>th</sup> governor on January 11, 1965. He was re-elected in 1968, the first governor to serve two terms.

During his tenure, Hearnese signed a Public Accommodations Law ending housing segregation, strengthened the Fair Employment Practices Act, and increased the staff of the Human Rights Commission. Funding for public education was doubled, state aid to higher education tripled, and aid to vocational education increased from \$856,000 to \$8.8 million.

Additional accomplishments included 350 miles of constructed four-lane highways, creation of the Missouri Division of Highway Safety, added 250 new officers for the Missouri State Highway Patrol, and signed legislation provided for mandatory breath tests of suspected drunk drivers.

After leaving office, Hearnese ran an unsuccessful campaign for U.S. Senate in 1976, losing to John Danforth, and in 1978 was defeated by James F. Antonio for State Auditor. He was appointed Circuit Court Judge for the 33<sup>rd</sup> District (Mississippi and Scott counties) in 1980, becoming the only Missourian to hold office in all three branches of state government. Hearnese worked for the Southeast Missouri Legal Services as executive director from 1981 to 1997. Hearnese died on August 16, 2009 in Charleston and is interred in the International Order of Odd Fellowes Cemetery.

## Advisory Commission on Intergovernmental Relations, 1964-1972

### Scope and Content

Contains communications, studies, and other files related to the Advisory Commission on Intergovernmental Relations.

Originally called the Kestnbaum Commission, the Commission was initially formed in 1953 with the stated goal of "improving the effectiveness of the American federal system through increased cooperation among National, State, and local levels of government." The newly named Advisory Commission on Inter-Governmental Relations became a permanent body in 1959 and existed until 1996.

The committee consisted of 26 members consisting of: 3 private citizens (appointed by the President), 3 U.S Senators, 3 U.S. Representatives, 3 officers of the Executive Branch, 4 Governors, 3 State legislators, 4 mayors, and 3 county officials. Members serve 2-year terms.

Box 307 contains materials pertaining to burst pipes at housing projects, explosions, floods, and tornadoes. Materials include brochures, correspondence, declarations of disaster from President Lyndon Johnson, federal disaster circulars, estimates, and handbooks, flood control conference minutes, lists, maps, memoranda, newspaper clippings, petitions, pamphlets, press releases, requests for disaster aid, and telegrams.

Includes materials pertaining to the 1964 Missouri River and tributary floods in northwest Missouri and the 1965 Mississippi River floods in northeast Missouri. Also includes materials pertaining to tornadoes in Buchanan, DeKalb, Grundy and Platte counties (April 10, 1965), tornado damage in St. Louis (January 24, 1967), and the Potosi tornado (December 21, 1967).

Box 308 contains three miscellaneous disaster files. The bulk of the box pertains to civil disorder and includes correspondence and materials on demonstrations, riots, and reports on civil disorder to the governors of New Jersey and Washington.

Civil disorder files continue in Box 309. Also includes materials pertaining to office rental investigation (state paying such high rent for office space), letters and newspaper articles criticizing the National Governor's Conference at Tan-Tar-A Resort, the controversy over the State selling part of Babler State Park, and the Schapeler expense account dispute.

## Remitter of Bond Forfeiture, 1966-1971

### Scope and Content

The Missouri Revised Statutes (Section 217.805) give power to the governor to grant a remittitur (or remitter) for “any fine imposed by any statute, and for any forfeiture of a recognizance.” The latter are surety bonds made for the appearance of accused persons in court; the sureties for the bond are held liable in the amount agreed to by the court if the accused fails to show for trial. The governor must find that by such fine or forfeiture “an injustice [is] done, or great hardship suffered.”

According to the statute, applications for relief must include a statement of facts in the case, signed by the judge or prosecuting attorney, and a certificate from the clerk that all costs have been paid. The governor then files his decision in the case, along with the supporting documentation, with the secretary of state.

Remitters of Bond Forfeiture in this series were transferred from RG3.48, Records of Joseph Patrick Teasdale, 1977-1981.
