Historical and Biographical Notes

Christopher Samuel Bond was born in St. Louis on March 6, 1939 to Arthur Doerr and Elizabeth Green Bond of Mexico, Missouri. He is the grandson of the late A. P. Green, who founded the refractory manufacturing company A. P. Green Industries in Mexico, Missouri. Bond received his college education at Princeton University and his law degree in 1963 from the University of Virginia. He married Carolyn Reid on May 13, 1967 in Lexington, Kentucky. They met in Atlanta, where she was employed as a public-school speech therapist. They divorced in 1995. Bond had one child (Samuel) with Carolyn Reid. Bond married Linda Pell of Kansas City in 2002.

On July 1, 1963, Bond accepted a clerkship with the United States Court of Appeals for the Fifth Circuit in Atlanta, Georgia, and held that position until June 30, 1964. In November 1964 he was employed by Covington and Burling, a law firm in Washington, D.C. He remained with the firm until October 1967 when he returned to Mexico to practice law. He unsuccessfully ran for Missouri's Ninth U. S. Congressional District in 1968.

Bond served as an assistant attorney general and chief counsel of the Consumer Protection Division of the Missouri Attorney General's Office from January 1969 to June 1970.

Bond was elected State Auditor on November 4, 1970, and took office on January 12, 1971. He was the twenty-eighth State Auditor of Missouri and at 31 years of age, the youngest person to hold that office. He was State Auditor when he ran for Governor in 1972.

Elected for a first term as governor in 1972, he established a merit system for hiring, secured passage of an open meetings law, and led a petition drive for campaign contributions legislation as some of his main accomplishments. Bond was narrowly defeated for a second consecutive term in 1976 by Joseph Patrick Teasdale. Bond successfully ran for re-election in 1980 and was sworn in as the 49th Governor of Missouri on January 12, 1981. During his second administration, the governor expanded the Parents as Teachers Program state wide and balanced the budget shortfall from the previous administration.

In 1986 Bond was elected to the U. S. Senate. He served as chairman of the Senate Small Business Committee from 1995 until 2001. Bond was re-elected in 1992, 1998, and 2004 but decided against a fifth term. Bond left the Senate in January 2011 and joined the law firm of Thompson Coburn of St. Louis and Washington, D.C. He launched his own firm, Kit Bond Strategies, in November 2011.
