Historical and Biographical Notes

John David Ashcroft was born in Chicago, Illinois on May 9, 1942 to James Robert Ashcroft and Grace Larsen. He attended Springfield, Missouri public schools and graduated in 1964 from Yale University. Ashcroft received a law degree in 1967 from the University of Chicago School of Law and was admitted to the Missouri Bar. He married Janet E. Roede in 1967 and they have three children. The couple returned to Springfield, practiced law together, and taught on the business faculty at Missouri State University.

Ashcroft lost his first Congressional campaign in 1972 in the Republican primary. He was appointed to fill an unexpired term in the to the office of State Auditor in 1972 by Governor Kit Bond. After Ashcroft was defeated for the same position in the general election in 1974, he was hired by Missouri Attorney General John Danforth as a legal assistant, sharing an office with Clarence Thomas. In 1976, Ashcroft was elected as Missouri Attorney General and served in that position until 1985.

He defeated Ken Rothman in the 1984 gubernatorial election and was sworn in as Missouri's 50th Governor on January 14, 1985. He was re-elected in 1988. As governor, Ashcroft balanced eight consecutive state budgets, created the Department of Health, established the Missouri Scholars Academy and the Bright Flight Scholarship, and implemented the Excellence in Education Act of 1985. He increased funding for local law enforcement, successfully pushed for tougher sentences for gun crimes, and stronger punishment for people who brought guns into schools. Additionally, the Missouri General Assembly enacted hate crimes legislation and passed the Missouri Victim's Bill of Rights.

John Danforth retired from the U. S. Senate in 1994 and Ashcroft successfully ran for the open seat. Ashcroft served on the Senate Judiciary Committee and as chairman of the Constitution Committee. Ashcroft was defeated for re-election in the 2000 campaign. President-elect George W. Bush nominated Ashcroft as U. S. Attorney General. He was confirmed by the Senate and served from 2001 through 2005. After resigning on February 3, 2005, Ashcroft formed the Ashcroft Group, a Washington lobbying firm.
