Historical and Biographical Notes

Eric Greitens was born in St. Louis, Missouri on April 10th, 1974 to Becky and Rob Greitens. His mother was a special education teacher while his father worked for the Missouri Department of Agriculture as an accountant. He grew up with two younger brothers, Marc and Aaron. Greitens was raised Jewish, through his mother, while his father was Catholic. He married Rebecca Wright in 2000; they divorced in 2003. Greitens married Sheena Chestnut in 2011; they divorced in 2020. The couple has two children.

Greitens graduated from Duke University in 1996 summa cum laude, majoring in ethics, philosophy, and public policy. He was named both a Truman Scholar and a Rhodes Scholar and pursued graduate studies in philosophy at Oxford University, obtaining a doctorate. His dissertation focused on the challenges international humanitarian organizations face dealing with children in war zones. During his university years, he was an amateur boxer, competing in events representing both Duke and Oxford. Greitens also participated in humanitarian missions in Croatia, Bosnia, Rwanda, and Bolivia.

Shortly after finishing his Ph. D., Greitens enrolled at the United States Navy Officer Candidate School in Pensacola, Florida in 2001. Greitens graduated in May 2001 as an ensign in the U.S. Navy Reserve. He graduated Basic Underwater Demolitions/SEAL (BUD/S) training in February 2002. Greitens eventually became a lieutenant commander in the U.S. Navy Reserve and had four deployments to Iraq, Afghanistan, Horn of Africa, and Southeast Asia.

In 2005, Greitens left full-time active duty to take a White House fellowship. He helped develop a program to assist rebuilding efforts after Hurricane Katrina. Greitens also worked in the Department of Housing and Urban Development.

After his fellowship, Greitens volunteered for a six-month tour in Iraq. He was awarded a Purple Heart and other combat awards during his tour. Greitens used his military experiences to author three books: *Strength and Compassion: Photographs and Essays* (2008), *The Heart and the Fist: The Education of a Humanitarian, the Making of a Navy SEAL* (2011), and *Resilience: Hard-Won Wisdom for Living a Better Life* (2015).

Greitens was raised a Democrat but switched to the Republican party in 2015, citing issues related to the Department of Veterans Affairs. Shortly after his switch, Greitens ran for governor of Missouri, winning a competitive Republican primary against John Brunner, Peter Kinder, and Catherine Hanaway. He defeated Missouri Attorney General Chris Koster in the general election on November 8, 2016.

Greitens focused on a variety of legislation in his first year as governor, calling two special sessions. He signed bills in 2017 making Missouri a right-to-work state (later overturned by voter referendum in 2018), passing anti-abortion legislation, enacting legislation that lowered electricity rates for industrial companies, making foster care system reforms, and signed a “Blue Alert” law.

Greitens was the center of two controversies that came to light in 2018. The first was a report that Greitens had engaged in an extramarital affair with his hairstylist, which Greitens publicly disclosed ahead of the investigative report. On February 22, 2018, a St. Louis grand jury indicted Greitens on felony invasion of privacy charges. These charges were later dropped due to lack of evidence. A Missouri House Special Investigative Committee looked into the allegations and released a report stating that the women's claims were "credible".

The second controversy arose when then Missouri Attorney General Josh Hawley initiated an investigation into the governor's campaign fundraising. It was alleged the campaign used a Greitens-founded nonprofit charity's donor list without the charity's knowledge. Charges were filed by the St. Louis Circuit Attorney's Office that were later dismissed.

The state legislature convened a special session on May 18, 2018 to consider impeachment. On May 29th, 2018 Greitens announced his resignation effective June 1st 2018. He was replaced by Lt. Governor Mike Parson.

Greitens ran for the open U.S. Senate seat in Missouri in 2022 but finished third in the Republican primary election.
