SESSION LAWS, 1838-2025

Arrangement: Chronological by session

Scope and Content

The series contains bills and resolutions signed into law in the state of Missouri from 1838 to the present. Each law bears the signature of the speaker of the Missouri House of Representatives, the President Pro Tem of the Missouri Senate, and the Governor of Missouri (except for bills passed into law during veto sessions, which do not bear the Governor's signature).

The compilations from each General Assembly are variously entitled Legislative Rolls, Session Acts, Laws of Missouri, and Truly Agreed to and Finally Passed Bills. Between 1838 and 1855, the laws of each session are divided into Private Acts and Public Acts. Between 1856 and 1961, they are arranged by General Assembly. Between 1963 and 1981, they are arranged by General Assembly and are designated as House Bills and Senate Bills. Between 1982 and 1990, the laws are compiled by legislative session and are divided into House Bills and Senate Bills. After 1990, the laws are arranged by legislative session and are divided into House Bills, Senate Bills, House Joint Resolutions, and Senate Joint Resolutions. Starting in 1996, any resolutions are filed after respective House or Senate bills. Bills passed during veto sessions or extraordinary sessions are filed after the bills and resolutions of the regular session for that year.

As required by the Missouri Constitution, the report of the Missouri Citizens Commission on Compensation for Elected Officials is filed "by the secretary of state as a part of the session laws of the general assembly" (Article XIII, Section 3). The reports start in 1996 and are to be filed every two years; however, there is a gap between 1998 and 2006 when the commission was inactive.

Between 1838 and 1990, the session laws are contained in bound volumes; after 1990, they are contained in boxes and folders. Between 1838 and 1931, the laws are hand-written; between 1933 and 1981, they are typewritten; after 1981, they are printed. After 1945, veto bills are included and are located with tabs.

Veto bills, which are fully vetoed by the governor in their entirety, are separated from approved bills and put at the end of each session. However, bills with line item vetoes, where the governor strikes out only a part of a (often funding) bill, are found with approved bills. Both veto bills and line item bills may be overridden during the annual veto session.

The series includes an Index to the Legislative Rolls as of 1861.
