#### **Scope and Content**

This series consists certifications of candidates for statewide office (and some judicial offices) and samples of political party emblems for parties appearing on Missouri election ballots. Party emblems are the illustrations that identify a particular party on a ballot; some parties have both national and state emblems, which may differ. The candidate listings are grouped by party affiliation and include home addresses.

Originally, the "Certification of Candidates" booklets pertained to those candidates certified to campaign for primary elections and "Certification of Nominations" pertained to those candidates who were elected at the primary for the general (November) election. In the 1986, the two separate documents were combined under one title, "Certification of Candidates," published twice: once before the primary election and once before the general election.

For some election years, supplemental certifications were made to update the printed booklets. Where found, these supplements are kept in the same folder as the booklets.

In November 1990, certification of party emblems was added. Previously, this had been a separate series, which has now been included here. Actual representations of emblems may or may not be found for particular election years, as some have only correspondence. Party emblems may also be found in the series *Party Formation Petitions*.
