Processing Information: Processed and collated from previously processed petitions, miscellaneous elections, and unprocessed records by Mary Kay Coker on April 27, 2022. The date of the petition is generally for the next general election (even years), though a few approved petitions appeared in special elections on odd years. A very high number of duplicates are found in this series with copies sent between elections staff, state auditor, and attorney general. Put in chronological order and keep only the original record. A

sampling of original signed petition sheets for any one petition should be no more than five per agreement with Elections.

Historical and Biographical Notes

Adopted by constitutional amendment in 1908, the initiative petition is used for getting a law proposed and passed directly by the people, either as an ordinary law or a constitutional amendment. The referendum is a public vote on a prior action of the legislature and is used primarily for controversial bills. A referendum may be ordered by the General Assembly, by passing a regular bill, or the people may force a referendum by circulating petitions.

The right of citizens to initiate petitions and referendums is guaranteed by Article III, Section 49, of the Missouri Constitution. The process is regulated by Chapter 116 of the Revised Statutes of Missouri.

After a petition or referendum is submitted, the secretary of state “shall prepare and transmit to the attorney general fair ballot language statements that fairly and accurately explain what a vote for and what a vote against the measure represent.” (RSMo 115.025) The ballot language can, and often has been, challenged in court. The state auditor prepares a fiscal note and summary of the financial impact on the state budget. Once certified, the ballot language (or title) can be circulated for signatures.

According to the current Missouri Constitution (Article III, Section 50, January 2021), “Initiative petitions proposing amendments to the constitution shall be signed by eight percent of the legal voters in each of two-thirds of the congressional districts in the State, and petitions proposing laws shall be signed by five percent of such voters.”

Only a small fraction of submitted petitions make it through the entire process and are placed on the ballot. Many are rejected or withdrawn early in the process. There may also be many different versions of a petition and only one is chosen to circulate. A large number of those certified are never circulated for signature. And of those that are, even fewer gather enough signatures to be placed on the ballot.

INITIATIVE PETITIONS AND REFERENDUMS, 1912-2022

Extent: 22.8 cubic ft. (57 Hollinger boxes)

Arrangement: Chronological by election year when petition or referendum was to be voted on and thereunder alphabetical (early) or numerical (recent) with referendums first. Within a folder, the most recent certification of ballot title and/or (in)sufficiency is placed first followed by the rest of the records in chronological order.

Scope and Content

Early petitions, which were only haphazardly kept before 2000, are mostly signature sheets or printed proposed amendments or legislation. Around 2002, the content became more uniform, using the year and sequential numbering for each individual petition.

Contents may include a submission cover sheet; original time-stamped petition or initiating legislation; acknowledgement of receipt; correspondence between the petitioner, secretary of state, state auditor, and attorney general; attorney general opinion; fiscal note and summary; occasional public comment or rare press clipping; withdrawals; litigation; receipt and box count of signed petitions; sampling of original signed petitions; and certification of official ballot title and/or certificate of sufficiency (or insufficiency) of required signatures.

Some petitions became part of an investigation, such as when signatures were alleged to be fraudulent, and such records can be quite voluminous. These records are cross-referenced but will be found in the Elections investigative files, which cover more than just petitions.

For the years 2008-2012, Elections appears to have only kept those petitions where the submitter had turned in signature pages, with the majority having sufficient signatures to be put on the ballot. A few were rejected petitions. From 2014 on, the records are complete.
