HISTORICAL AND BIOGRAPHICAL NOTES

The Missouri State Militia was created in November, 1861. The governor of Missouri would have authority over the Missouri State Militia while the federal government would pay all costs. The Missouri State Militia would not be required to serve outside the state of Missouri. Veterans of the Missouri State Militia were granted federal pensions after the war.

Regimental returns are paperwork created by various batteries, regiments and battalions and submitted to the Adjutant General. These records are the kind of bureaucratic paperwork on which the Army marched. Due to the chaotic nature of the Civil War in Missouri, the lack of reliable postal service, and poor record keeping in the field, these records are very incomplete.

The Scope and Content Note for individual regiments contains information on organization, disbanding, transfers and consolidations. Also noted are exceptional records of interest.
