## HISTORICAL NOTE

Multiple laws regarding the organization of Missouri's militia have been passed since before Missouri became a state. During early statehood and the Civil War period, Quartermasters General were appointed by the governor and approved by the senate. The Quartermaster General was second in command to the Adjutant General, and submitted reports directly to the governor and General Assembly.

The Quartermaster General, along with his staff, was responsible for keeping Missouri's military units supplied. This necessarily created a large amount of paperwork. The majority of the records in this collection are abstracts: forms consolidating and summarizing information from requisitions, receipts and correspondence. The Quartermaster General coordinated receiving and disbursing supplies and services from both the federal government and local contractors.

Many of the Quartermaster General records overlap with the regimental returns for various units.
