HISTORICAL AND BIOGRAPHICAL NOTES

Regimental returns are paperwork created by various companies, regiments and battalions and submitted to the Adjutant General. These records are the kind of bureaucratic paperwork on which the Army marched. Due to the chaotic nature of the Civil War in Missouri, the lack of reliable postal service, and poor record keeping in the field, these records are very incomplete.

This collection contains records from other states' units and Adjutants General offices. The majority of records are letters informing the Missouri Adjutant General of Missouri citizens who joined regiments from other states so that the Missouri Adjutant General could count those citizens against Missouri's quota.
