Historical and Biographical Notes

Robert Steven “Steve” Gaw was born in Moberly, MO on July 7, 1957. He attended and graduated Northeast Missouri State University (now Truman State University) with a Bachelor of Science in physics and later the University of Missouri-Columbia School of Law. Afterward receiving his degree, he practiced law in Moberly and served as city attorney. He married Fannie Bowdish and they have no children.

Gaw ran as a Democrat for the District 22 House seat in 1992 and won four consecutive terms, serving up to the 1999-2000 General Assembly. From 1997-2000 he served as Speaker of the House. In 2000, Representative Gaw ran for Missouri Secretary of State and lost to Matt Blunt. He served on the Missouri Public Service Commission from 2001-2007. In 2008, Gaw ran for the open 9th congressional district but lost to Judy Baker in the primary.

Representative Gaw served on several committees during his terms including: Agri-Business, Children, Youth and Families, Education-Higher, Judiciary and Ethics, Elections (chair), Appropriations-Education, and Appropriations-Public Safety.
