HISTORICAL AND BIOGRAPHICAL NOTES

John Smith Phelps was born in Simsbury, Connecticut on December 22, 1814 to Elisha Phelps and wife Lucy Smith Phelps. Educated at Trinity College in Hartford, Phelps was admitted to the Connecticut bar in 1835. After his marriage to Mary Whitney (1813-1878) in 1837, the couple moved to Springfield, Missouri where Phelps opened his law practice. The couple would have five children although only two survived to adulthood: John Elisha Phelps (1839-1921) and Mary Anne Phelps Montgomery (1846-1943).

A devotee of U.S. Senator Thomas Hart Benton early in his political career, John Smith Phelps later aligned himself with the anti-Benton Democrats, and then with the national Democratic Party. He was elected to the Missouri legislature in 1840 and in 1844 to the U. S. House of Representatives where he represented southwest Missouri for the next eighteen years. Congressman Phelps was recognized nationally for his support of an overland mail route to California, his efforts towards gaining Oregon statehood, and his work in the reduction of postage stamps to three cents per letter.

He served as chairman of the House Ways and Means Committee and although was in line to become Speaker of the House in 1860, ultimately failed to obtain the post. Congressman Phelps opposed secession and together with conditional Union and unconditional Union allies in the state legislature successfully kept Missouri in the Union during the secession crisis of 1861. Phelps did not stand for reelection in 1862 and upon leaving Congress, he recruited and commanded a Union regiment at the Battle of Pea Ridge, Arkansas in March 1862. In July 1862, hoping to establish a loyal civil government, President Lincoln appointed Phelps as military governor of Arkansas. Ill health forced Phelps to resign that commission in 1863.

Upon the conclusion of the Civil War, John Smith Phelps returned to his law practice in Springfield. Mr. Phelps successfully defended James Butler "Wild Bill" Hickok who had been tried for killing Dave Tutt in a duel in Springfield in 1865. Hickok was acquitted. Phelps unsuccessfully ran for governor as a Democrat in 1868; but in 1876, he defeated former Congressman Gustavus A. Finkelnburg in the general election on November 7. He received the largest majority vote of any Missouri governor from 1840 to 1920. Governor John Smith Phelps was sworn into office as Missouri's 23^{rd} governor on February 8, 1877.

The tenure of Governor Phelps was marked by a currency crisis triggered by the federal government ceasing the issuance of silver coins while simultaneously calling back the paper currency issued during the Civil War. Missouri also suffered from staggering war debt and related inflation, depressed wages, and business failures. In his inaugural address, Phelps advocated common schools for whites and blacks. He declared that any new state debt should be approved by the voters, urged the state to economize, and recommended that a tax be levied to pay interest on outstanding state debt. Governor Phelps also called for fair administration of the ballot and impartial interpretation of the constitution.

During the Phelps administration, the Missouri Bureau of Labor Statistics was created and appropriations for the Board of Immigration were approved. Legislation was enacted requiring counties to balance budgets unless otherwise approved by voters. The balance of state indebtedness was significantly reduced. The University of Missouri received biennial appropriations from the General Assembly for the first time and public schools received increased state financial support. Criminal laws were strictly enforced and the lawlessness that had plague Missouri since before the Civil War was reduced.

Governor Phelps retired from public service at the end of his gubernatorial term in 1881. He died in St. Louis on November 20, 1886 and is interred in Hazelwood Cemetery in Springfield, Greene County.

RECORDS OF GOVERNOR JOHN SMITH PHELPS, 1876-1881

Scope and Content

Correspondence comprise the records. The files have been organized topically (and thereunder chronologically) in the following order: Fines and Forfeitures, Fairs and Exhibitions, Appointments—Fulton State Hospital, Appointments—Miscellaneous, Appointments—Oil Inspectors, Appointments—Requests, Appointments—Resignations, Appointments—St. Louis, Appointments—State Penitentiary, and Personal Correspondence. Changes in organizational scheme are noted. Within each topic, non dated material is filed before dated materials. Appointments file headings are self explanatory. Other notable contents are listed below.

All references to places are within the state of Missouri unless indicated, and county is specified when known. The spelling of proper names varies greatly. When correct spelling could not be determined the original spelling was retained. Officeholders are Missouri officials unless noted (U.S. Senator, U.S. Secretary of State, U.S. Attorney General, U.S. Supreme Court, etc). State Representatives are referred to as Representative. U.S. Representatives are noted with the title Congressman.

When the collection was microfilmed, it was determined that some of the collection required rehousing. As a result, some folder numbers have changed. Original folder numbers are noted within parentheses. For example, 20 (6) indicates that the item originally in folder 6 is now located in folder 20.

Fairs and Exhibition files contain appointment requests and correspondence pertaining primarily to the 1876 Centennial Exposition in Philadelphia, Pennsylvania celebrating the 100th anniversary of the Declaration of Independence and the Revolutionary War. Governor Phelps also received notifications for the Convention for the Promotion of American Commerce in New Orleans; the Centennial Anniversary of the Surrender at Yorktown; World's Fair and Exposition in New York City (1883); and the Inter-State Convention (1880) for Mississippi River valley states also in New Orleans.

Appointments—Miscellaneous files include requests for appointments to the University of Missouri Board of Curators; to the Board of Regents for the Normal School in Kirksville; for various county probate judgeships and other county positions; to the State Board of Agriculture; and military academy appointments.

Appointment Requests files contain petitions and correspondence pertaining to the position of circuit clerk for the Chariton County Court. Candidates Thomas T. Elliot (the incumbent) and John Knappenberger provided Governor Phelps with petitions and correspondence supporting their bids for the office. The governor received five petitions for Mr. Elliot (folder 11). Folder 12 includes a listing of Chariton County officials recommending Mr. Knappenberger. Twenty two petitions signed by 870 citizens of Chariton County were sent to the governor on Knappenberger's behalf.

Communications pertaining to a variety of issues comprise the Personal Correspondence files. Topics include appeals for financial aid; the invention of a machine to exterminate grasshoppers;

proxy votes for stocks owned by the governor, requests for payment, statement of debts owed by Mrs. Phelps, and a receipt for payment; invitation to attend a wedding; a visit to New Madrid; notices from attorney on the settlement of estates; business interests and financial statements; political conditions in Green County, the rise of the National Independent Party (Greenback Party), Democrats, and Republicans; and a 1879 published report from the Committee appointed to visit the Missouri Institution for Education of the Blind to the Missouri General Assembly. Of special interest is a letter from U.S. Secretary of State John Hay (folder 27).
