Scope and Content

This series consists of appointments to state agencies, boards, committees, commissions, and some county positions. These files contain letters from the governor advising the Secretary of State that certain appointments had been made; some also include an oath of office taken by the individual, sample certificates/commissions, bonds, and miscellaneous correspondence from the Commissions Division.

Occasionally the files include non-gubernatorial appointments made at the department level, such as assistant state treasurers, compliance and investigation agents, and state technical assistance team investigators.

The files are arranged alphabetically by title of the board, committee, commission, or agency. In most cases, the word "Missouri" or "State" has been dropped from the beginning of the name, with alphabetizing beginning with the next *significant* word in the title. From 1838 to 1977, there is one alphabetical listing. From 1977 onwards, the span of years roughly corresponds to gubernatorial administrations, although there is some overlap. Occasionally the appointment and oath are separated between administrations.

Starting with the administration of Governor Parson in 2018, gubernatorial appointments are sent to the archives every year. Rather than start a new set every year, processing staff will make a folder without box or folder numbers but list them in the finding aid. Once the gubernatorial administration is completed, the ending date and box/folder numbers will be added.
