### MISSOURI-KANSAS BORDER WAR, 1858-1862

*Abstract:* Records (1858-1862) relating to the mid-nineteenth century conflict between Missourians and Kansas territorial settlers, commonly known as the Missouri-Kansas Border War, which preceded the Civil War. Records include governor's correspondence, muster rolls, military payroll records, and financial records primarily consisting of claims for payment.

### HISTORICAL NOTES

The Kansas-Nebraska Act, signed by President Franklin Pierce on May 31, 1854, organized the land west of Missouri into two territories, Kansas and Nebraska. Whether Kansas was a free or slave territory was of particular importance to Missouri because, if Kansas became free, the state would be surrounded by free soil on three sides.

According to the act, settlers in the Kansas Territory were to determine the issue of slavery through popular sovereignty, meaning the settlers would vote on whether slavery would be allowed. This act set the stage for a decade of border warfare, with offenses committed on both sides of the Missouri-Kansas border.

Missourians from the western counties began by raiding Kansas' territorial elections, attempting to establish a pro-slavery government through illegal voting and violence. As violence escalated in 1858, the attacks of Kansas invaders, referred to as "jayhawkers," led the citizens of western Missouri to request protection from Governor Robert Stewart.

In February 1859, the Missouri state legislature appropriated \$30,000 to suppress the troubles in western Missouri, and Stewart instructed the state's attorney general to organize militia companies in Bates and Cass counties in April. Although the spring and summer saw a brief cessation of hostility, sporadic violence continued through 1860. In late November 1860, Stewart sent a body of troops from St. Louis and Jefferson City to Vernon County to suppress the activities of Kansas guerrilla leader James Montgomery. The force was known as the Southwest Expedition, commanded by Brigadier General Daniel M. Frost.

Although order on the border was somewhat restored by December 1860, conflict continued throughout the Civil War. As a result, the Missouri-Kansas Border War, or "Bleeding Kansas," is often referred to as one of the events that ushered in the American Civil War.

### Scope and Content

This series contains incoming and outgoing correspondence of Governor Robert M. Stewart. Most of the letters are between the governor and the adjutant general or other military officials. In addition, there are letters from Missouri citizens and minimal correspondence between the governor and the territorial governors of Kansas, J.W. Denver and Samuel Medary.

The majority of correspondence relates to conditions along the Missouri-Kansas border, including information on specific violent acts and requests for protection; organization of volunteers for military service and the arming of troops; and depopulation of the border counties. A common theme in the correspondence is to protect the border but never cross it. Key figures mentioned include John Brown, James Montgomery, and Brigadier-General Daniel M. Frost.
