It is a class A misdemeanor punishable, notwithstanding the provisions of section 560.021, RSMo, to the contrary, for a term of imprisonment not to exceed one year in the county jail or a fine not to exceed ten thousand dollars or both, for anyone to sign any initiative petition with any name other than his or her own, or knowingly to sign his or her name more than once for the same measure for the same election, or to sign a petition when such person knows he or she is not a registered voter.

## Right to farm.

Be it resolved by the people of the state of Missouri that the Constitution be amended:

35 of Article I of the Constitution of Missouri is amended by modifying section 35. The existing section 35 is set forth hereinafter with the new matter bold and deleted matter in brackets,

### Definitions of terms, as used in this Act:

- a) Cannabis: refers to the cannabis, marihuana, marijuana, cannabis, sativa, cannabis indica, cannabis ruderalis, or any variety of cannabis, including but not limited to, derivative, concentrate, extract, flower, leaf, particle, preparation, resin, root, salt, seed, stalk, stem, or any product thereof
- b) Hemp: The fiber of this plant, extracted from the stem and used to make rope, fabrics, fiberboard, clothing, and paper. The sister plant of cannabis

That agriculture which provides food, energy, health benefits, and security is the foundation and stabilizing force of Missouri's economy. This section shall protect the right to grow cannabis and hemp. To protect this vital sector of Missouri's economy, the right of farmers and ranchers to engage in farming and ranching practices shall be forever guaranteed in this state, subject to duly authorized powers, if any, conferred by article VI of the Constitution of Missouri.
