Be it resolved by the people of the state of Missouri that the Constitution be amended:

This measure amends Article X section 26 of the Missouri Constitution by deleting all matters within the enclosed brackets and adding all the underlined matters as required pursuant to Section 116.050 RSMo.

- Section 26. A. In order to prohibit an increase in the tax burden on the citizens of Missouri without voter approval, state and local sales and use taxes (or any similar transaction-based tax) shall not be expanded to impose taxes on any service or transaction that was not [subject to sales, use or similar transaction-based tax on January 1, 2015.] approved by voters.
- B. Prohibit funding of sports and entertainment stadiums, recreation centers or facilities without voter approval.
- C. Prohibit expansion, extending, modifying, or amending current or future bonds, tax credits for the purpose of funding sports and entertainment centers, recreation centers or facilities, without voter approval.
- D. No unelected governmental body, committee, or commissions shall have the power to spend money, apply for grants, enter into agreements for the purpose of funding sports and entertainment centers, recreation centers or facilities. No unelected body of government body, committee, or commissions shall have to power to sue in any official capacity to dispute any part of this section.
- E. All provisions of this section are self-executing and severable, and, except where otherwise indicated in the text of this document, shall supersede conflicting city, county, state or federal statutory, local charter, ordinance, or resolution.
- All provisions shall take effect immediately upon passage.
