

It is a class A misdemeanor punishable, notwithstanding the provisions of section 560.021, RSMo, to the contrary, for a term of imprisonment not to exceed one year in the county jail or a fine not to exceed ten thousand dollars or both, for anyone to sign any initiative petition with any name other than his or her own, or knowingly to sign his or her name more than once for the same measure for the same election, or to sign a petition when such person knows he or she is not a registered voter.

BE IT RESOLVED BY THE PEOPLE of the state of Missouri that the Constitution be amended:

Article IV, Section 48 is amended by adding one new section known as 48(a), to read as follows:

No person operating a moving motor vehicle upon the highways of this state shall, by means of a hand-held electronic wireless communications device, make or take part in a phone call, or send, read, or write a text message or electronic message, unless the device is equipped with technology allowing for hands-free operation or equipped for voice-recognition hands-free texting and is being used in such manner. 2. Except as otherwise provided in this section, no person shall operate a commercial motor vehicle while using a hand-held mobile telephone. 3. Except as otherwise provided in this section, no person shall operate a commercial motor vehicle while using a wireless communications device to send, read, or write a text message or electronic message. 4. The provisions of subsection 1 through subsection 3 of this section shall not apply to a person operating: (1) An authorized emergency vehicle.
