

It is a class A misdemeanor punishable, notwithstanding the provisions of section 560.021, RSMo, to the contrary, for a term of imprisonment not to exceed one year in the county jail or a fine not to exceed ten thousand dollars or both, for anyone to sign any initiative petition with any name other than his or her own, or knowingly to sign his or her name more than once for the same measure for the same election, or to sign a petition when such person knows he or she is not a registered voter.

**BE IT RESOLVED BY THE PEOPLE of the state of Missouri that the Constitution be amended:**

Article V entitled Judicial Department, is amended by adding one new section to be known as Section 32, to read as follows:

The Supreme Court allows certified paralegals or legal assistants certified by a credited college or university, without attending law school, to shadow and work alongside of an attorney at law for a period of three years. Thereafter, the person would be allowed to take a bar exam and if passed, demonstrating good moral character and financial responsibility per State Supreme Court rules, will be able to practice law in Missouri and will be accepted by the Supreme Court and the Appeals Courts and all Courts and Tribunals in the state and have the same basic rights to practice law and give legal advice to the People of the state.
