Be it resolved by the people of the state of Missouri that the Constitution be amended:

Article I of the Constitution is revised by amending Section 1 to read as follows:

- **Section 1.** (a) That all political power is vested in and derived from the people; that all government of right originates from the people, is founded upon their will only, and is instituted solely for the good of the whole.
- (b) To ensure that the General Assembly of the State of Missouri reflects the will of the people as accurately as possible, every citizen of the state of Missouri who is eligible to vote may submit a proxy form to one member of the house of representatives and one senator naming them as their designated representatives.
- (c) Each citizen who is eligible to vote may submit a new proxy form designating a different representative and/or senator as their representative(s) at any time, but no more than once in any calendar year for each office.
- (d) With the exception of votes taken to override a governor's veto, for which each member will cast a single non-weighted vote, senators and representatives shall have weighted votes on all matters that come before the General Assembly, including votes in senate and house committees, based on the number of proxies they hold from citizens of the state of Missouri.
- (e) The value of each representative's weighted vote, rounded to the nearest hundredth of a full vote, shall be determined by dividing the number of proxies held by each representative by the number of proxies held by the representative with the lowest number of proxies.
- (f) The value of each senator's weighted vote, rounded to the nearest hundredth of a full vote, shall be determined by dividing the number of proxies held by each senator by the number of proxies held by the senator with the lowest number of proxies.
- (g) The Secretary of State shall design a proxy form, a form for voters to use to change their proxies, and a form for citizens to submit cancelling their proxies if they move out of the state or are no longer eligible to vote, and make those forms available to citizens of the state of Missouri.
- (h) The General Assembly shall pass appropriate legislation implementing a secure system for the transmission and recording of proxies and providing penalties for forging or falsifying proxies.
