PRELIMINARY PETITION SIGNATURE COUNTY REPORTS

The information contained in this report is provided in the interest of transparency and public awareness as part of Secretary of State Denny Hoskins' transparency initiatives related to initiative petitions and referendums. The Missouri Secretary of State's Office is committed to providing the public with timely insight into the progress of the petition review process while maintaining the integrity and accuracy required by Missouri law.

The data presented in this report indicates information provided by local election authorities' verification processes pursuant to RSMo 116.130.4. This report is preliminary and reflects the current stage of review by the Missouri Secretary of State's Office as of July 27, 2026.

Petition signatures undergo a multi-step review process that includes:

- verification,
- quality control,
- and certification.

As this work progresses by local election authorities and the Missouri Secretary of State's Office, additional review may identify:

- duplicate signatures,
- incomplete information,
- or other factors that may affect final certification totals.

For this reason, the figures contained in this report do not represent final counts and remain subject to change as the review process continues.

These reports are part of a developing transparency effort by the Missouri Secretary of State's Office to provide the public with regular updates on the status of petitions. Because this reporting process is evolving alongside the review work itself, formats, metrics, and levels of detail may be refined over time as the Office continues to improve how information is shared with the public.

This report is provided for informational purposes only and should not be interpreted as a final determination regarding petition validity or certification. Final determinations will be made only after the Missouri Secretary of State completes the full verification and certification process required under Missouri law.
