FY24 Long Term Grants ·

The grant dates for the FY24 long-term grants were moved thirty days later in comparison to prior years to minimize the issue of not having a timely annual federal budget, which stops the allocation and distribution of IMLS funding. All future grants continue to be susceptible to this funding allocation. Since the long-term grants come earliest in the Missouri State Library grant cycle, these are most likely the only grants affected. The grant call schedule lists the application due dates and report due dates of all scheduled grants.

The Digital Imaging Grant (DIG) is currently viewable in the online grant management system. This grant requires a <u>Letter of Intent</u> be submitted by Jan. 15, 2024 as one of the

eligibility requirements for this grant. If you have any questions on the DIG, please contact Matt at matthew.butler@sos.mo.gov.

Upcoming grant application due dates:

- Spotlight on Literacy application is due Feb. 28, 2024.
- Digital Imaging Grant application is due March 15, 2024.
- Technology Ladder application is due April 1, 2024.

With the exception of the DIG, all other scheduled grant applications open approximately 45 days prior to the due date

Deflect OCLC Loan Requests from Outside the U.S. -

OCLC recently announced a new profiled group designed to enable US libraries to deflect loan requests from outside the US. The group was created in response to several requests from OCLC libraries in the US that cannot lend physical loans outside the country, for example, due to prohibitive shipping costs or customs requirements. Similar groups have been formed in other countries and regions for the same reason.

The new OSUS (Libraries outside of US) group includes all OCLC interlibrary loan libraries

physically located outside the US. By using the OSUS group, libraries in the US can now create a straightforward policy to automatically deflect all loan requests from libraries outside the US. Brooklyn Public Library 2023 Library Card Access Survey -

The Association for Rural and Small Libraries is partnering with Brooklyn Public Library to distribute an important survey on cardholder signup policies at public libraries across the United States. The survey should take about 25 minutes to complete.

Purpose: By responding to this survey, you are contributing to the first known sampling of public library card access trends across the United States. The survey collects data about your

library's cardholder signup process for adults and children/teenagers, as well as how these policies and procedures are revised. Brooklyn Public Library will share findings in a report issued to the field in spring 2024; and will convene a working group next summer to publish a framework for library leaders of best practices around cardholder access.

Grant Opportunities

Educational Presenter Grant • Deadline: Ongoing

This open-call grant is a combination of the previously offered Author Visit Grant and the Bicentennial Programs Grant, and will replace the two separate grants. Libraries can apply to bring an author or educational presentation to their community. This application is open

to Missouri public libraries certified to receive FY23 state aid, Missouri school libraries publicly supported and publicly controlled, and Missouri academic libraries supported publicly or privately.

Penguin Random House Grants for Small Libraries

Through the generosity of Penguin Random House, a new grant opportunity for small, rural libraries is available nationwide! This grant is available to libraries that meet both the IMLS definition for small libraries (a service population of 25,000 or fewer) and the definition for rural libraries (libraries located 5 or more miles from the nearest town of 25k or more).

Applicants may request:

- One (1) monetary grant in support of a community-oriented project for up to \$1,000
 OR
- An in-kind grant donation of up to \$1,000 in equivalent value to support a circulating collection in your library.

The program will award grants to libraries that demonstrate a true need. First-time recipients

will receive priority when reviewing the applications. Monetary grants are not limited to literacy and may be used for everything from library programming and books to resources like hotspots that help community members access important information. Libraries seeking support for digital collections should request a monetary grant. Applications may be submitted beginning Dec. 4. Access the application here when it opens. Deadline to submit applications is Dec. 15.

Notifications of funding decision will be sent to applicants by March 8, 2024.

Funded projects must be completed by Dec. 31, 2024.

Project reports must be submitted by Feb. 1, 2025.
