IMLS, Califa Group, Wyoming and Missouri State Libraries, and Lifetime Arts Launch \$1.2 Million Project to Advance Creative Aging

By 2030, older adults (55+) will be the dominant demographic group in the United States, and institutions are adapting to meet their needs for meaningful engagement. A total of 132 public and county library systems in Missouri and Wyoming will develop and/or expand arts education programs that improve the lives of older adults through the Advancing Creative Aging Through State Library Leadership Initiative (2023-2025). In partnership with the participating state libraries, Lifetime Arts will train and coach up to 250 librarians and library programmers in creative aging program planning, design, marketing, implementation, and documentation. One hundred in-person and remote creative aging programs will serve up to 2,000 older

adults in Wyoming and Missouri public libraries and build the case for long-term sustainability. Nationally, thousands more libraries and their staff will benefit through networking opportunities and the dissemination of the virtual self-paced course, Creative Aging Foundations on Demand from Lifetime Arts. This three-year initiative is made possible through a partnership between [Califa Group](#), [Wyoming State Library](#), [Missouri State Library](#), and [Lifetime Arts](#). The project is generously supported by a \$646,000 Laura Bush 21st Century Librarian grant from the [Institute of Museum and Library Services](#) (IMLS), and builds on IMLS's longtime support of creative aging in libraries. STAR Net Eclipse Workshop on March 16, 10 a.m. - 4 p.m. at Cape Girardeau Public Library

MOSL has teamed with STAR Net programs to help library staff prepare for the 2023 and 2024 solar eclipses. The workshop will prepare and empower public library staff to facilitate meaningful solar and space science programs for their patrons. Attendees will receive hands-on training on operating solar telescopes and other methods for direct and indirect solar viewing, best practices for developing and facilitating STEM programs, and how to engage with community partners. STAR Net facilitators will help library staff build off the excitement of the 2023 and 2024 solar eclipses, engage their patrons in solar science activities, safely and

effectively facilitate direct and indirect methods of safe solar viewing, and develop and facilitate exciting and interactive STEM programming at their library. STAR Net will also be supplying Eclipse viewing kits that will circulate as the current STEM kits do. The workshop will use materials from the circulation kits and highlight best practices in using those materials, but the strategies, activities and resources shared during the workshop will be useful to attendees whether they have access to a circulation kit or not. ALA's FY2022 Preservation Statistics Survey

The ALA/Core Preservation Standards and Practices Committee (PS&P) is pleased to announce that the [FY2022 Preservation Statistics Survey](#) is now open. Due to the pandemic, this is the first time the survey has run since 2020 for FY2019. Your data contribution greatly impacts the understanding of preservation activities and trends across libraries of many types. ALA invites you to complete the survey to the best of your ability, and the survey will close on **March 1, 2023**.

The Preservation Statistics Survey is a project to document and analyze the preservation activities of cultural heritage institutions in the United States. Preservation activities encompass a broad range of tasks to ensure long-term access to traditional and digital cultural heritage collections in libraries, museums, archives, historical societies, and more. American Library Association Graduate Program Scholarships

The [American Library Association \(ALA\) Scholarship Program](#) has more than \$300,000 available to students who are studying in library science or school library media programs at the master's degree level. They include scholarships for students who are interested in children's librarianship, youth librarianship, federal librarianship, new media, and library automation. In addition, there are also scholarships available for minorities, persons with disabilities, and people who are already employed in libraries but do not have an MLS.

The scholarship process is open annually from September – March 1. Applications and reference forms (which must be submitted online) are available during that time period. Instructions and general information remain available year round. You can apply for a variety of scholarships through the single online application hosted by the ALA Scholarship Program.





TechSoup Introduces Cloud Support Services for Microsoft Cloud Subscriptions

Starting on January 4, all Microsoft Office and Microsoft 365 cloud licenses obtained through TechSoup will include Cloud Support Services delivered by TechSoup. This service will allow TechSoup to help nonprofits and libraries determine which Microsoft cloud licenses are right for them, how to activate those licenses properly, and how to fully realize the value of this powerful but complex platform. As a result, pricing for some of their cloud subscriptions will

be affected. Libraries will still have an option to receive donated licenses directly from Microsoft at no cost to you, but these will not include any of the TechSoup support services. WordPress is a free, easy-to-use tool to create great-functioning and great-looking websites. In this course, schools and libraries will learn how to set up a basic website using templates, plug-ins and add-ons. Once set up, the WordPress

Why watch your students and patrons playing video games when you could watch them design and create the game themselves? Microsoft's MakeCode platform allows users to create throwback arcade games and create in Minecraft Edu. This education version of Minecraft builds upon the traditional game by adding lesson plans and guided activities for a wide range of content areas and subjects. Reference Services for YOU: CFPB and the Library

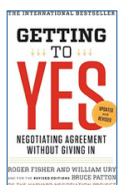
The Consumer Financial Protection Bureau's primary function is to enforce consumer financial laws and provide consumer protection, but encouraging financial literacy has become a core focus for the agency.

For promoting personal financial literacy, [publications](#) and online tools are available to patrons for enhancing their education from childhood through retirement. Resources for individuals to learn about their financial well-being score or to look up the [consumer complaint database](#) are also available.

Of particular interest, the CFPB created a Libraries Initiative with [Resources for Libraries and Librarians](#) containing outreach and program ideas designed for public library use. The librarian training [webinars](#) focus on how libraries can discuss and promote financial literacy topics with patrons. The CFPB also provides free online and paper publications geared toward libraries, including financial education bookmarks.

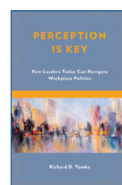

Grant Opportunities

Technology Ladder Grant • **Deadline: March 1, 2023**

The 2023 Technology Ladder Grant is open in the online grant management system. Applications are due by March 1, 2023, with a grant period of April 15, 2023 to March 30, 2024. This grant is for purchasing technology and technology-related projects that require more than five months to complete. The eligibility requirements include the requirement to have and maintain an active Unique Entity Identifier in the name of the library registered through SAM.gov and a current Work Authorization on file with the Missouri Office

of Administration. See the Award Guidance for the full list of eligibility requirements and the minimum and maximum awards. It is recommended applicants print a copy of the Award Guidance for their grant file and as an aid in completing the application. Also, notice the thresholds for the required local match have been raised to follow the increase in technology pricing. Educational Presenter Grant • **Deadline: Ongoing**

This open-call grant is a combination of the previously offered Author Visit Grant and the Bicentennial Programs Grant, and will replace the two separate grants. Libraries can apply to bring an author or educational presentation to their

community. This application is open to Missouri public libraries certified to receive FY22 state aid, Missouri school libraries publicly supported and publicly controlled, and Missouri academic libraries supported publicly or privately.
