#### Missouri State Government Information Conference

The Missouri State Library is partnering with the University of Missouri to host a *Missouri State Government Information Conference* in the fall of 2017. The goal of the conference is to include participants from throughout the life cycle of state government information to facilitate discussion and improve collaboration. An initial planning meeting took place on Monday, March 20 at the Secretary of State's Office in the James C. Kirkpatrick State Information Center. Participants in the discussion and planning process included representatives from the MU Law Library, MU Libraries, State Archives, State Historical Society, Supreme Court Library, Legislative Library, MoDOT Library and the State Library. ## FY17 State Aid Per Capita and A&E 3rd and 4th Quarter Payments

State Aid and Athlete and Entertainers (A&E) payments for FY2017 Q3 and Q4 are posted at <u>State</u> <u>Funding for Public Libraries</u>. They can also be viewed on the <u>Vendor Payment Portal</u>, which provides information on all payments distributed from the State of Missouri, as well as a notification when a payment is posted.

Per Capita State Aid and A&E tax revenue funds are distributed to all public libraries certified to receive state aid. A&E funds must be used to purchase materials to enhance the library collection,

whereas State Aid can be spent in multiple areas like programs, technology, building maintenance, personnel, furniture, and library collections.

#### FY 2018 State Aid Certification

It is again time to file the State Aid certification paperwork. In order to be certified for fiscal year 2018, the following three (3) forms must be completed and submitted to the Missouri State Library by email, fax OR mail by July 31, 2017:

- I. State Aid Application
- 2. List of Trustees
- 3. Certification of Compliance Form

Please note the State Aid application requires the reporting of State Aid Per Capita funds received between July 1, 2016 and June 30, 2017 and how those funds have been or will be spent for all libraries, regardless of the library's fiscal year. This is a change from previous years.

### **More April 2017 Library Election Results**

Both subdistricts of **Jefferson County Library** voted to increase their tax rate from 20 cents per hundred dollars of assessed valuation to 28 cents. The tax rate increase is intended to:

- provide for future maintenance and upkeep of the library facilities
- expand print, media and electronic collections to meet demand
- implement outreach programs and services
- improve technology services
- build partnerships with other educational agencies in the community
- maintain financial stability of the Arnold, Windsor and Northwest branches

#### Measures That Matter Webinar from IMLS and COSLA

As part of the Measures that Matter initiative, Chief Officers of State Library Agencies (COSLA) and the Institute of Museum and Library Services (IMLS) will offer a free, three-part webinar series about the public library data landscape during May, June, and July. The first webinar, "Measures that Matter: A View into the Current Public Library Data Landscape," will occur on May 23, from 2-3 p.m. This session will look at several major library surveys and data collection tools, and consider opportunities to pursue a national action plan to move toward obtaining more meaningful measures to demonstrate

## Mountain View Public Library Joins Missouri Evergreen, and Jefferson County Library Goes Live.

Evergreen was founded by four libraries in the Spring of 2012. Five years later, Mountain View Public Library is the 36<sup>th</sup> library system to join Missouri Evergreen. Mountain View and five other libraries (Festus Public Library, Texas County Library, Trails Regional Library, Livingston County Library, and Douglas County Library) will migrate to the Missouri Evergreen Integrated Library System within the next 10 months. Jefferson County Library went live on Missouri Evergreen on April 17, 2017.

Missouri Evergreen now contains 1,045,157 bibliographic records and 1,891,247 items. It represents 372,714 patrons. Missouri Evergreen has demonstrated that patron-initiated requests via the Evergreen system is an extremely effective way of increasing resource sharing among libraries. In 2016, the number of requests made in Missouri Evergreen was only 7 percent lower than the number of interlibrary loan requests made by public libraries statewide in OCLC. The number of requests filled was 10 percent higher.
